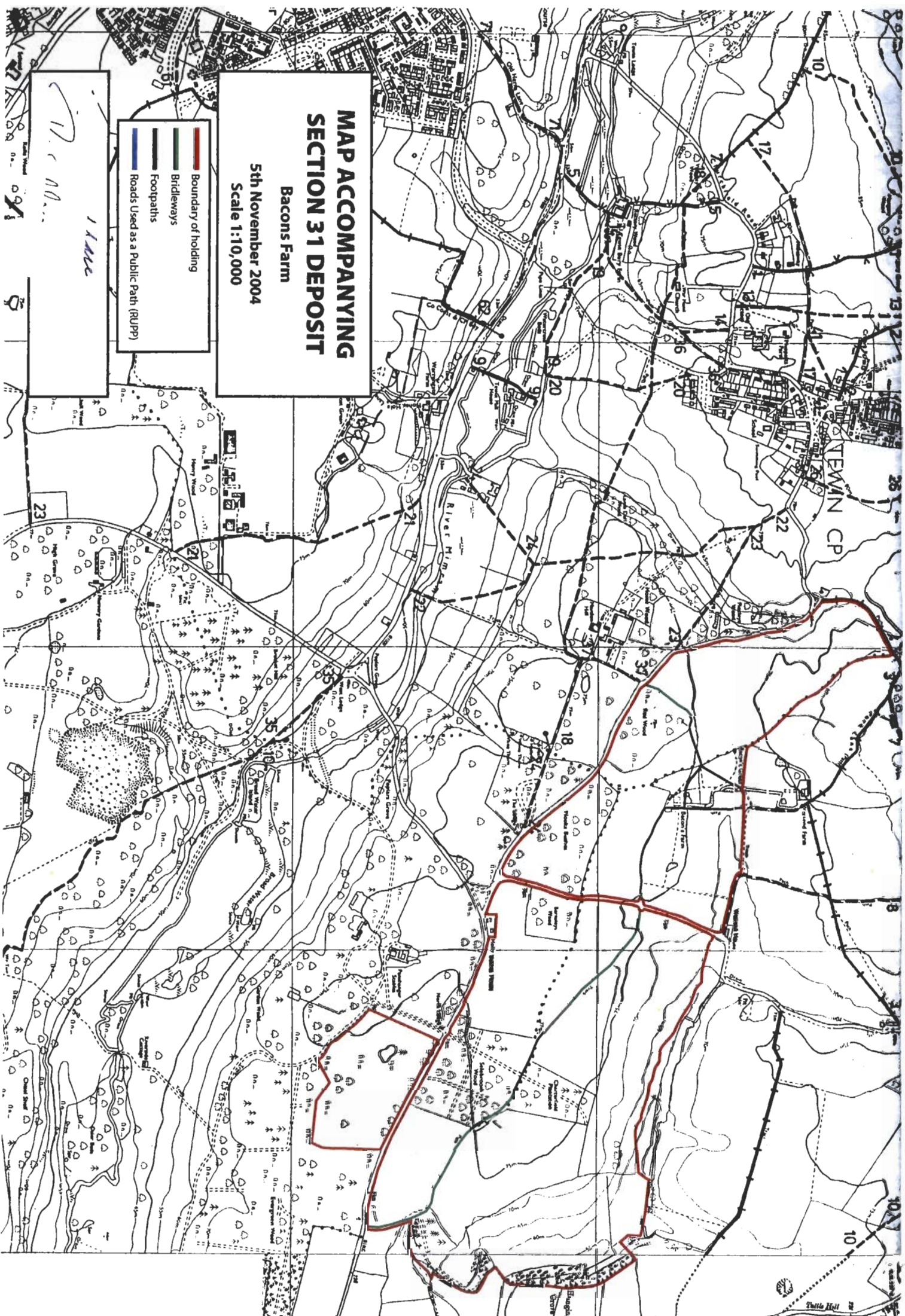
**MAP ACCOMPANYING

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

WE, J [redacted] AND ROBERT [redacted] E, DO SOLEMNLY
AND SINCERELY DECLARE AS FOLLOWS:

1. We are, and have been since December 1969, the owners of the land known as **Bacons Farm** more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 5th day of November, 2004 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:

the ways coloured **purple** on the said plan and the plan accompanying this declaration had been dedicated as footpaths,

the ways coloured **green** on the said plan and the plan accompanying this declaration had been dedicated as **bridleways**.

No other ways had been dedicated as highways over our property.

3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 5th November, 2004 referred to in section 2 above and at the present time we have no intention of dedicating any more public rights of way over our property.
