I enclose a notice as required by the above Act declaring there to be no public highways on the property known as Stocking Wood between White Stubbs Lane and Pembridge Lane.


It is the owner's intention not to dedicate any highways over this property by depositing a Statutory Declaration to this effect within six years from today and to repeat this process thereafter.


