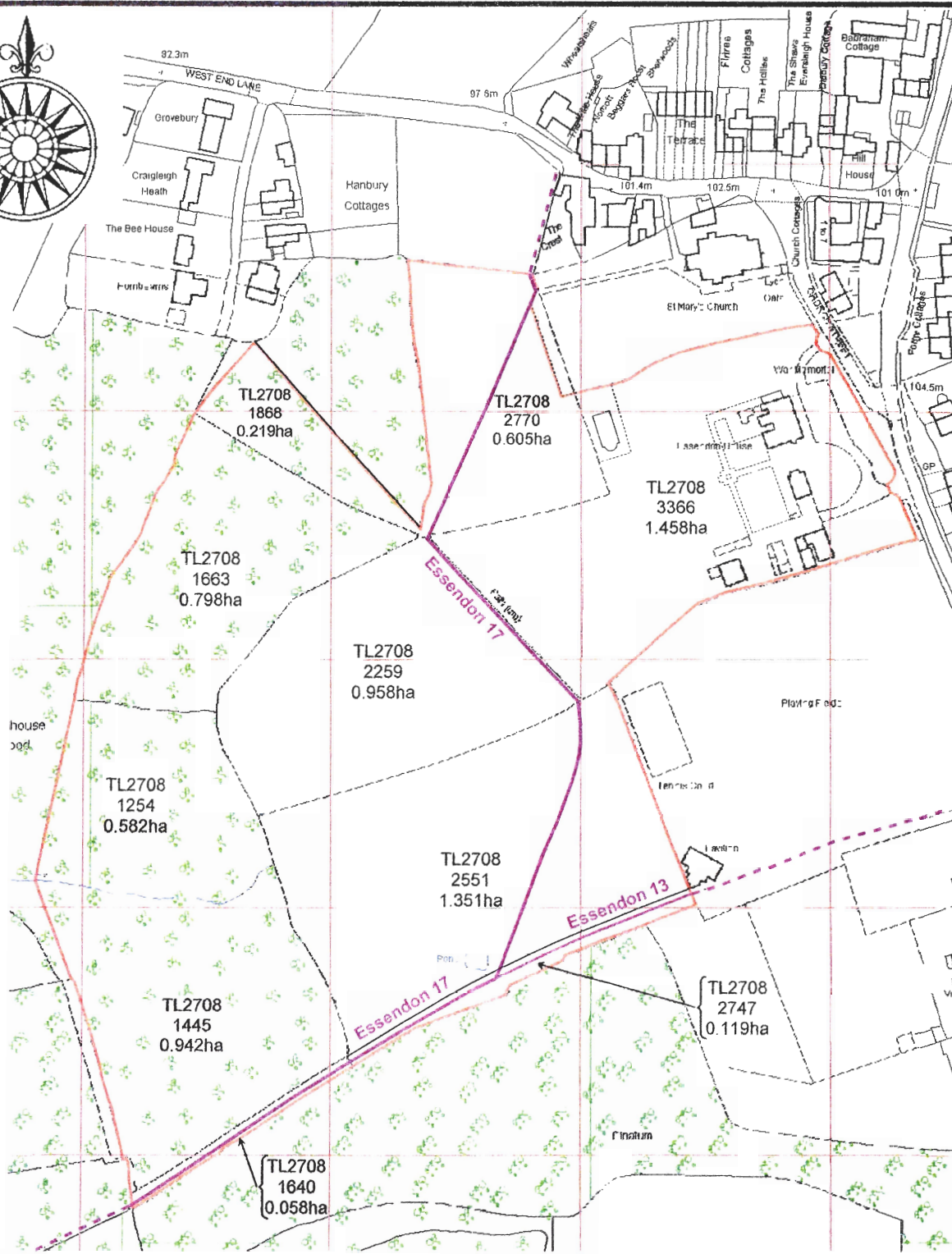

# STATUTORY DECLARATION

## SECTION 31(6) OF THE HIGHWAYS ACT 1980

I MARTIN REITH DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 18<sup>th</sup> May 2005 the owner of the land known as Essendon House, Essendon, Hatfield, Hertfordshire AL9 6AR more particularly delineated on the map reference 0077-SP/MR.01.10-Rev accompanying this declaration and thereon edged red.
2. On the 7<sup>th</sup> day of February 2011 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated that the ways coloured purple\* on the said map and on the map accompanying this declaration had been dedicated as public footpaths. No other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 7<sup>th</sup> February 2011 referred to in (2) above other than those public footpaths marked in the appropriate colour on the map accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

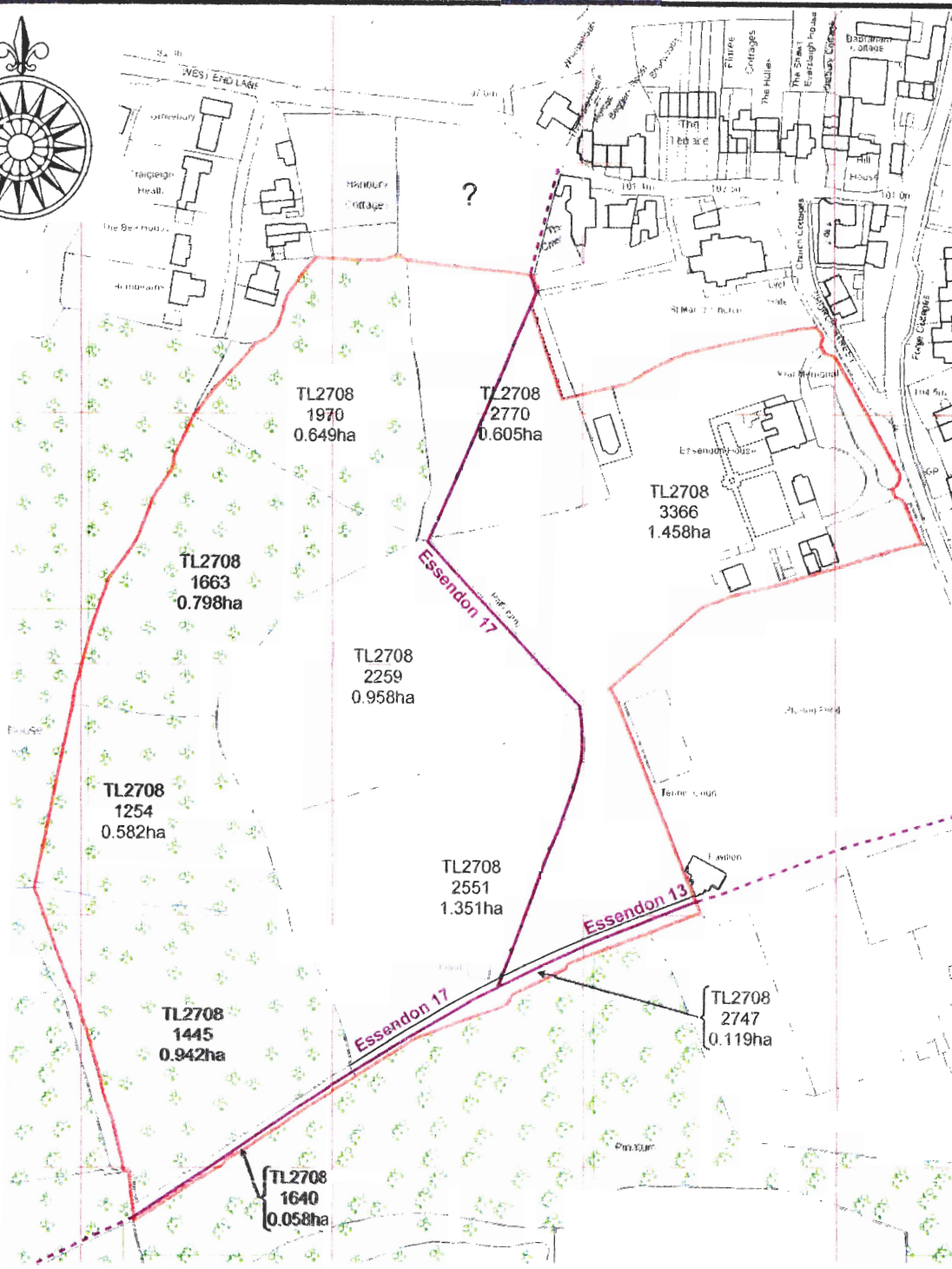
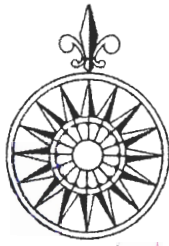
