

STATUTORY DECLARATION

SECTION 31 (6) of the HIGHWAYS ACT 1980

- 1. We are and have been since 9 January 2006 the owners of the land known as Cotton Spring Farm, Flamstead, Hertfordshire AL3 8AF more particularly delineated on the plan accompanying this declaration and thereon edged in red.
- 2. On the 17 October 2011 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured in purple on the said plan accompanying this declaration had been dedicated as footpaths.
- 3. No additional ways have been dedicated over land edged red on the plan accompanying this declaration since the statement dated 17 October 2011 referred to in 2 above other than those footpaths marked in the appropriate colour on the plan accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
