

## STATUTORY DECLARATION

### SECTION 31 (6) of the Highways Act 1980

We, The Trustees of the Gaddesden Trust DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. That since the 25<sup>th</sup> July 2006, The Gaddesden Trust have been the owners of the land known as The Home Farm more particularly delineated on the plan accompanying this declaration and thereon edged and shaded in red.
2. On the 1<sup>st</sup> day of November 2007, Strutt & Parker deposited with Hertfordshire County Council, as the appropriate Council, a statement accompanied by a plan delineating the Home Farm property by red edging and shading stating that the ways coloured purple on the said plan have been dedicated as footpaths and the ways coloured pink on the plan have been dedicated as bridleways. No other ways have been dedicated as highways over the property.
3. The ways coloured in blue squares on the said plans are as Permissive Riding Tracks that are not intended to become Public Rights of Way at any time and are only available for use by members of "Gaddesden Riding".
4. No additional ways have been dedicated over the land edged and shaded red on the plan accompanying this declaration since the statement dated the 1<sup>st</sup> day of November 2007 referred to in 2. above and at the present time The Gaddesden Trust have no intention of dedicating any more public rights of way over the property.

AND MAKE this solemn declaration on the 27<sup>th</sup> day of February 2008, conscientiously believing it to be true and by virtue of the Statutory Declaration Act 1835.

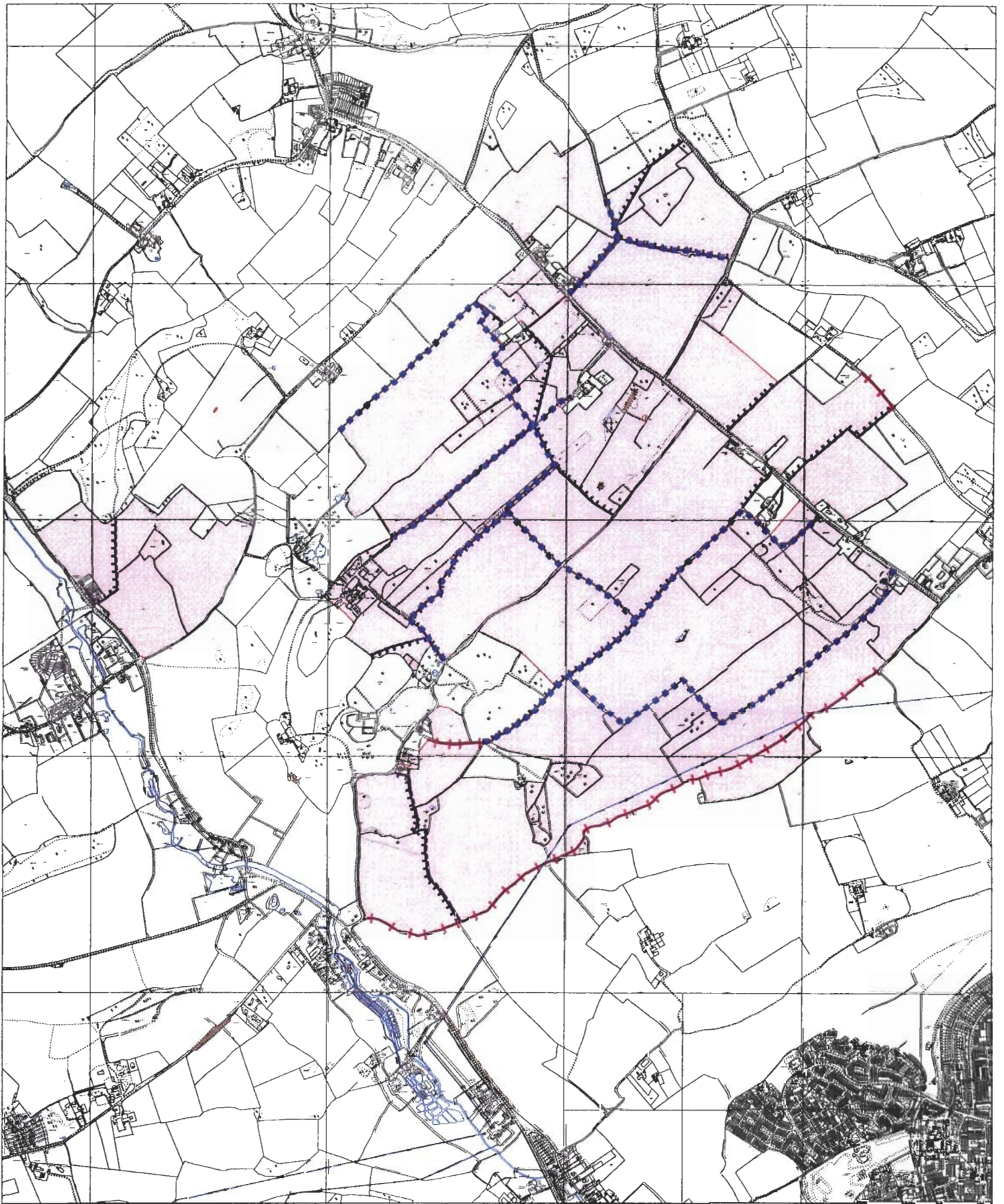
