

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I DO SOLEMNLY AND SINCERELY DECLARE AS
FOLLOWS:

1. I am and have been since 1974 the owner of the land known as Wood Farm more particularly delineated on the plan previously deposited and thereon edged red.
2. On the 5th day of March 1994 I deposited with Northfriesland County Council, an appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured brown on the said plan had been dedicated as highways with vehicular status, the ways coloured green on the said plan had been dedicated as bridleways, the ways coloured purple on the said plan had been dedicated as footpaths, and the permitted right of way as coloured, and no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated on the land edged red on the deposited plan since the statement dated 5th day of March 1994 referred to in 2. above and at the present time I have no intention of dedicating any more public rights of way over my property.

AND I MAKE this solemn declaration on the 27th day of January 2001 conscientiously believing it to be true and by virtue on the Statutory Declarations Act 1835.






