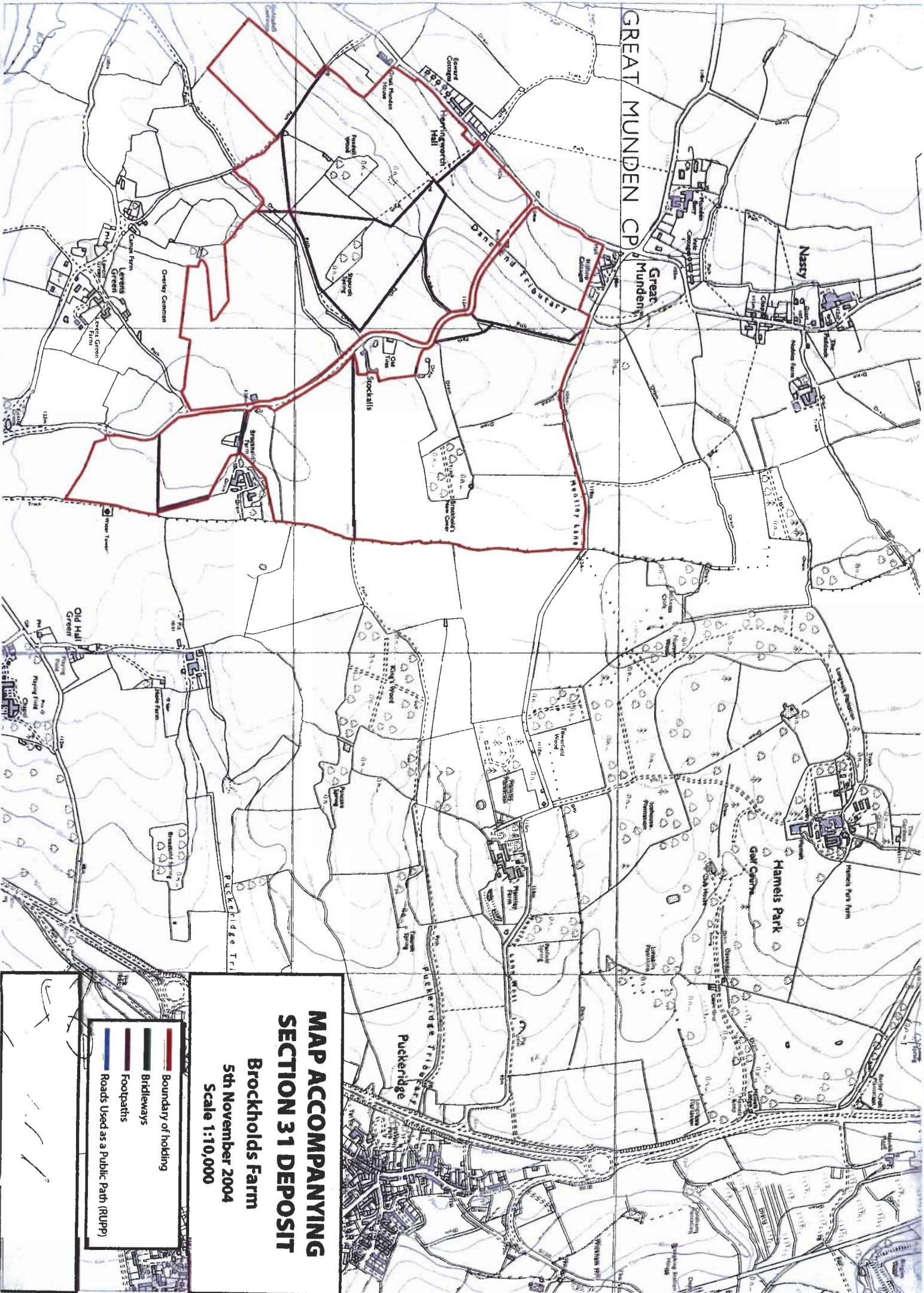

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

WE, **JAMESON AND HILL**, DO SOLEMNLY AND SINCERELY DECLARE AS FOLLOWS:

1. We are, and have been since 2nd April 1992, the owners of the land known as **Brockholds Farm** more particularly delineated on the plan accompanying this declaration and thereon edged red.
