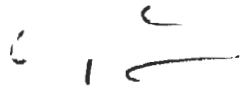
I, _____, of _____, Jersey, JE _____ do solemnly and sincerely declare that:

1. I am one of the two Trustees of the Aldwickbury Settlement ("the Trustees"). I am duly authorised to make this declaration on behalf of the Trustees in connection with a deposit of statement and map pursuant to section 31(6) of the Highways Act 1980.
2. The Trustees are the owners of the land at Harpenden ("the Land") shown for identification purposes only edged red on the plan now produced and shown to me and marked "MEAA1" which is to the best of my knowledge and belief accurate.
3. On 10 March 1998 the Trustees (through Kent Jones and Done Solicitors) deposited with Hertfordshire County Council, being the appropriate Council, a statement dated 4 March 1998 accompanied by a map identifying the Land by red edging which stated that the ways shown coloured purple on the said map and the plan at "MEAA1" had been dedicated as footpaths over the Land and that no other ways had been dedicated as highways over the Land.
4. No additional ways have been dedicated over the Land since the statement dated 4 March 1998 referred to in paragraph 3 above and at the present time the Trustees have no intention of dedicating any more public rights of way over the Land.
