

Statutory Declaration Section 31(6) of the Highways Act 1980

We, Too Solemnly And Sincerely Declare as follows:

- 1. We are and have been since April3rd1988 the owners of the land known as Land at Hammonds End Farm more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. On the 3. 2002 We deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths no other ways had been dedicated as highways over our property.
- 3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 3 2 2002 referred to in 2. above and at the present time we have no intention of dedicating any more public rights of way over our property.




