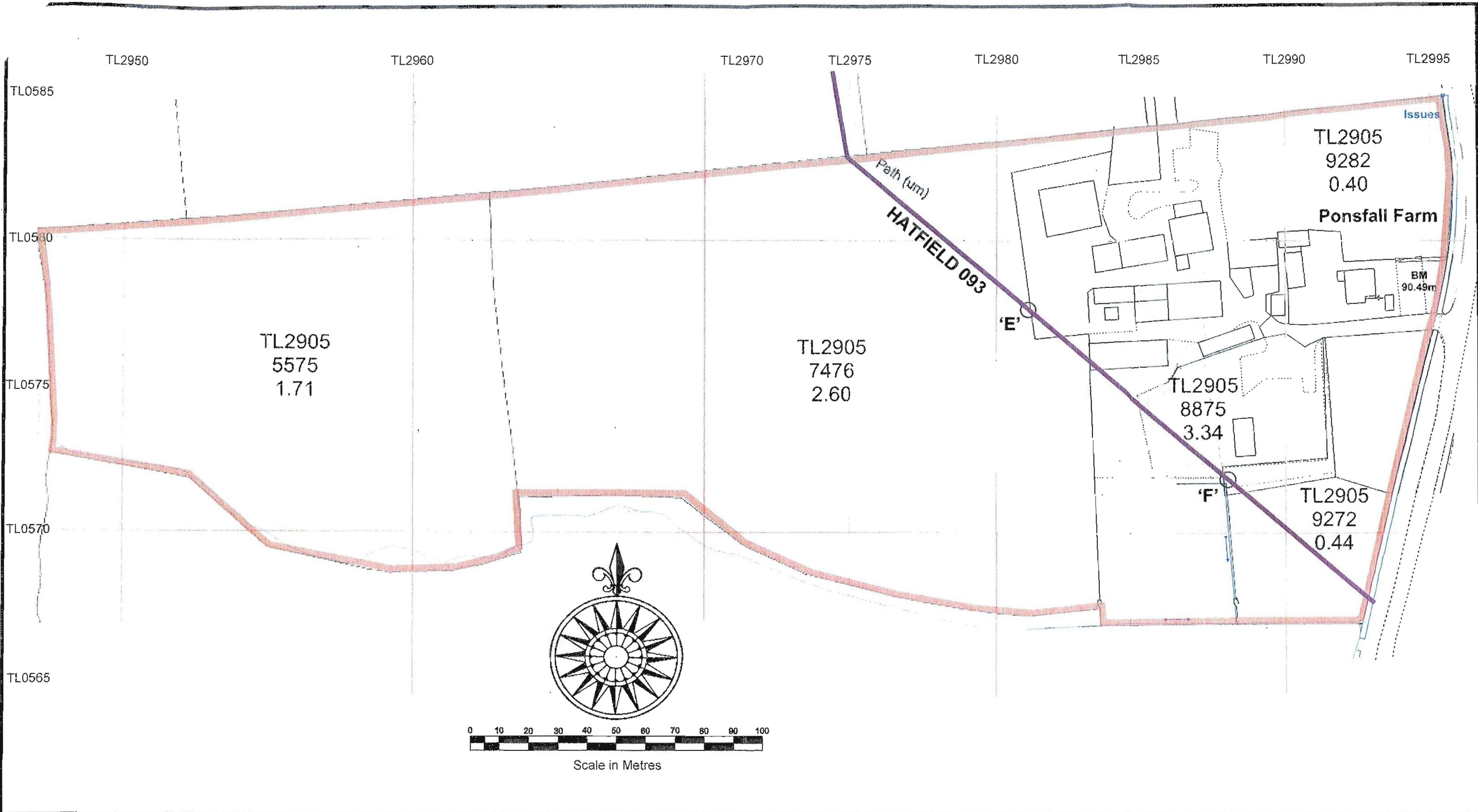

# STATUTORY DECLARATION

## SECTION 31(6) OF THE HIGHWAYS ACT 1980

1. I am and have been since 10<sup>th</sup> August 2007 the owner of the land known as Ponsfall Farm, Newgate Street Village, Near Hertford, Hertfordshire SG13 8NH more particularly delineated on the map reference 0158-FP/JDRS.01.12 accompanying this declaration and thereon edged red.
2. On the 7<sup>th</sup> day of March 2013 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated that the way coloured purple on the said map and on the map accompanying this declaration had been dedicated as a public footpath. It is possible to get through between points 'E'-'F' with some minor deviations. An alternative route has been provided whilst a formal diversion is sought. No other ways have been dedicated as highways over my property.
3. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 7<sup>th</sup> March 2013 referred to in (2) above other than the footpath marked in the appropriate colour on the map accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

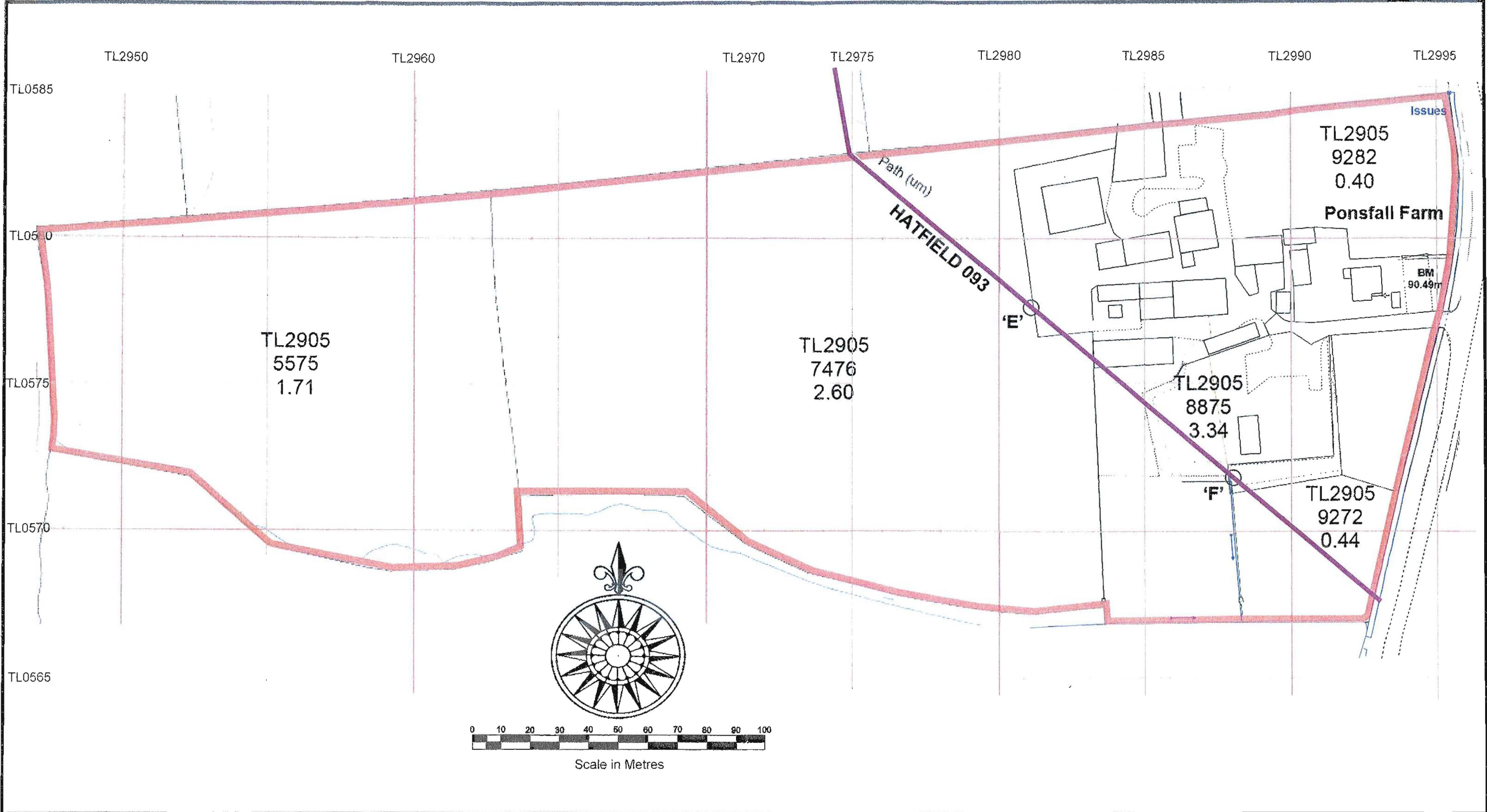
