

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

WE, THE UNDERSIGNED, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We are and have been since 10 October 1973 the owners of the land known as Bardon Farm, Ware Park, Ware, Hertfordshire SG12 0EB more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 16th day of February 2000 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the way coloured blue on the said plan and on the plan accompanying this declaration had been dedicated as a Roads Used as a Public Path; the way coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as a footpath. No other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 16 February 2000 referred to in 2 above and at the present time we have no intention of dedicating any more public rights of way over our property.

AND WE MAKE this solemn declaration on the 21 day of February 2000, conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.




