

STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980


I, F of Landmatch Limited, 1 Buckingham Place, London, SW1E 6HR, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We are and have been since 13th June 2001 the owners of the land known as High Leigh Farm more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the 27th day of July 2004 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths and the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways.
3. No additional ways have been dedicated over land edged red on the plan accompanying this declaration since the statement dated 27th July 2004 referred to in 2. above other than those footpaths and bridleways marked in the appropriate colour on the plan accompanying this declaration and at the present time we have no intention of dedicating any more public rights of way over our property.

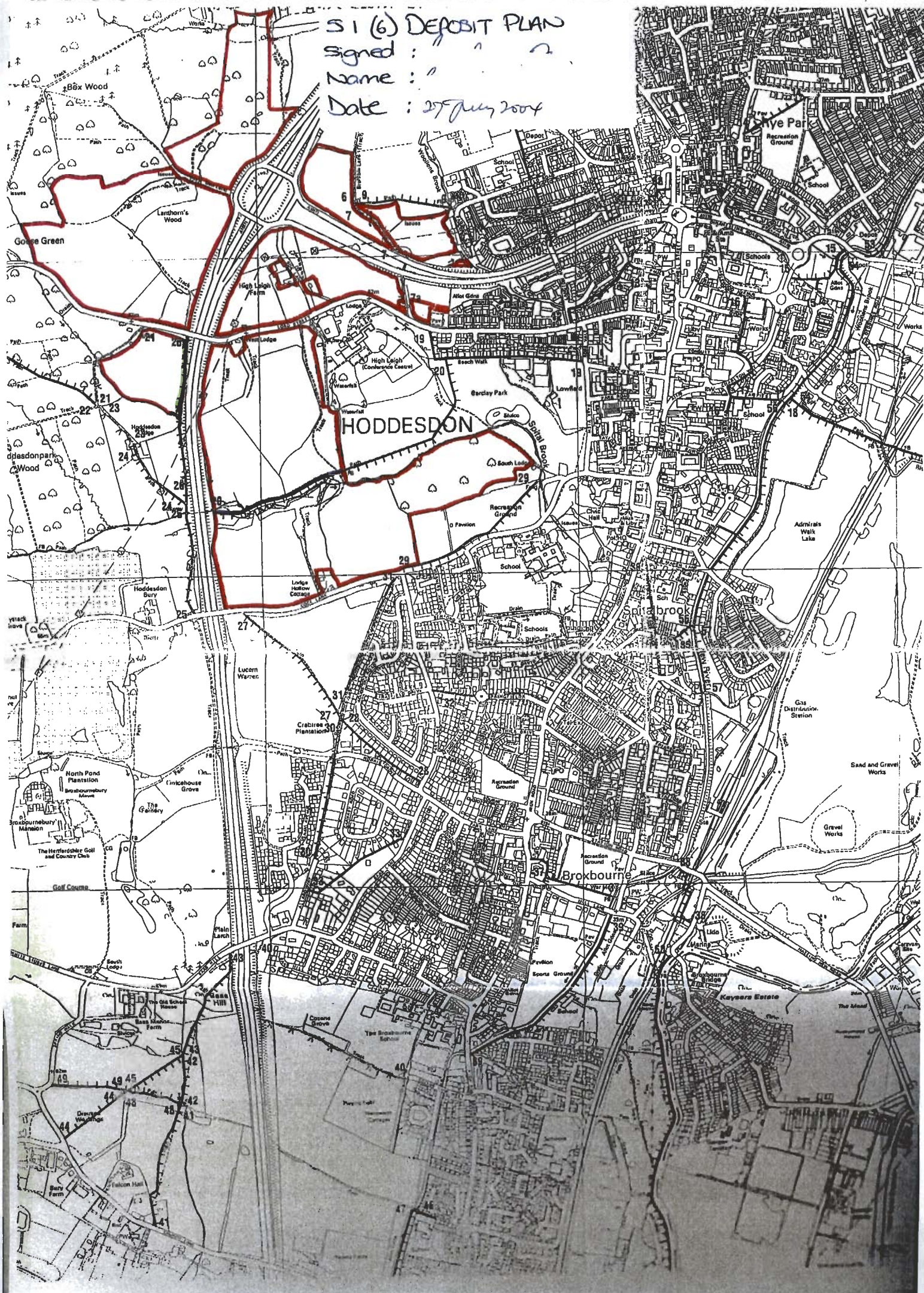
