## HIGHWAYS ACT 1980 SECTION 31 (6)

### I SOLEMNLY AND SINCERELY DECLARE as follows:


- 1. Highways Act 1980 - Section 31 (6) Hoddesdonpark Wood, Hoddesdon, Herts


