**STATUTORY DECLARATION
SECTION 31(6) of the HIGHWAYS ACT 1980**

1. We are and have been since 12 December 2007 the owners of the land forming part of the land known as Holwellbury Farm, Great Offley, Hertfordshire SG5 3BP more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the *5th February* 2011 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths, the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways and no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over land edged red on the plan accompanying this declaration since the statement dated *5th February 2011* referred to in 2 above other than those footpaths and bridleways marked in the appropriate colour on the plan accompanying this declaration and at the present time we have no intention of dedicating any more public rights of way over our property.

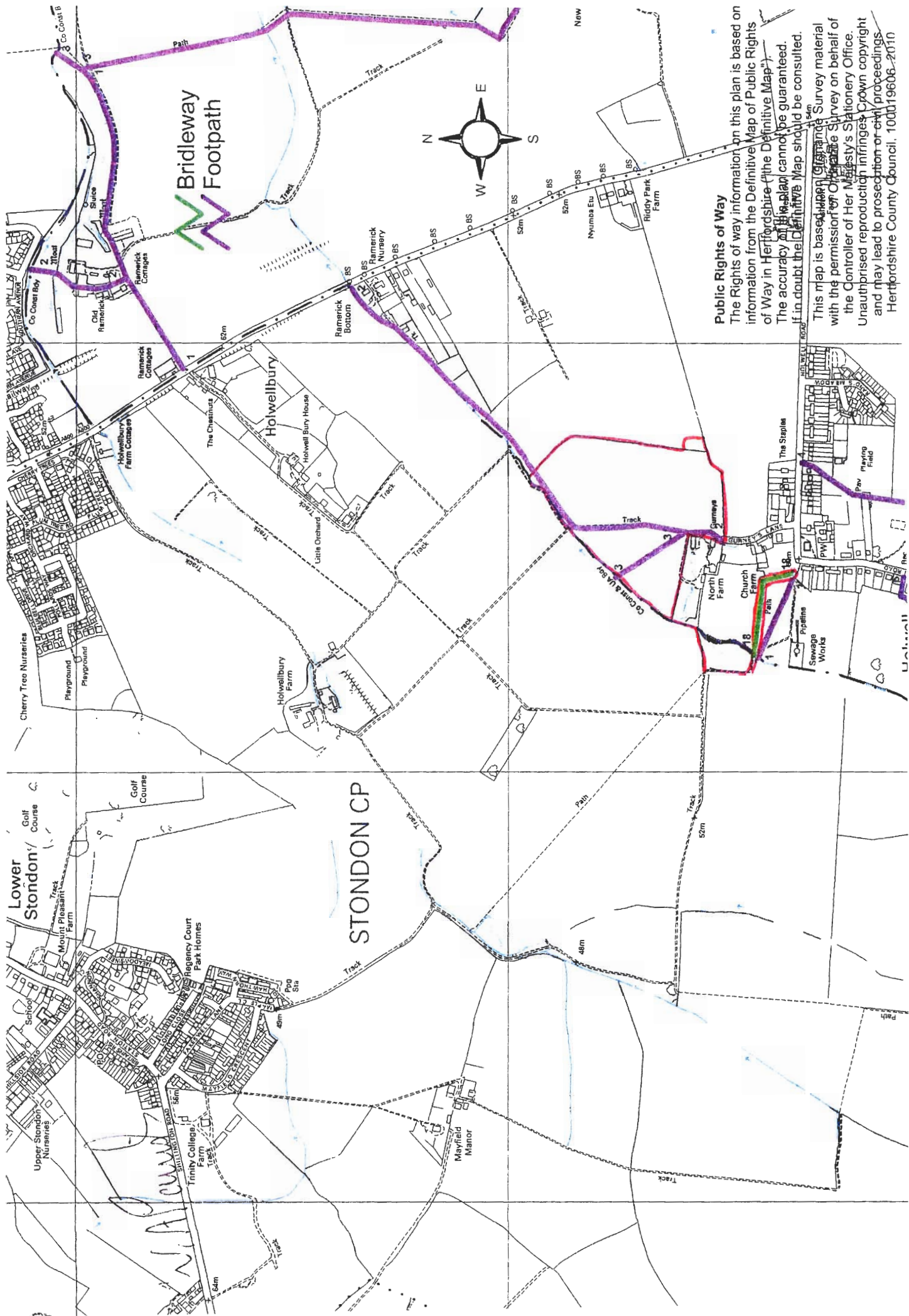
