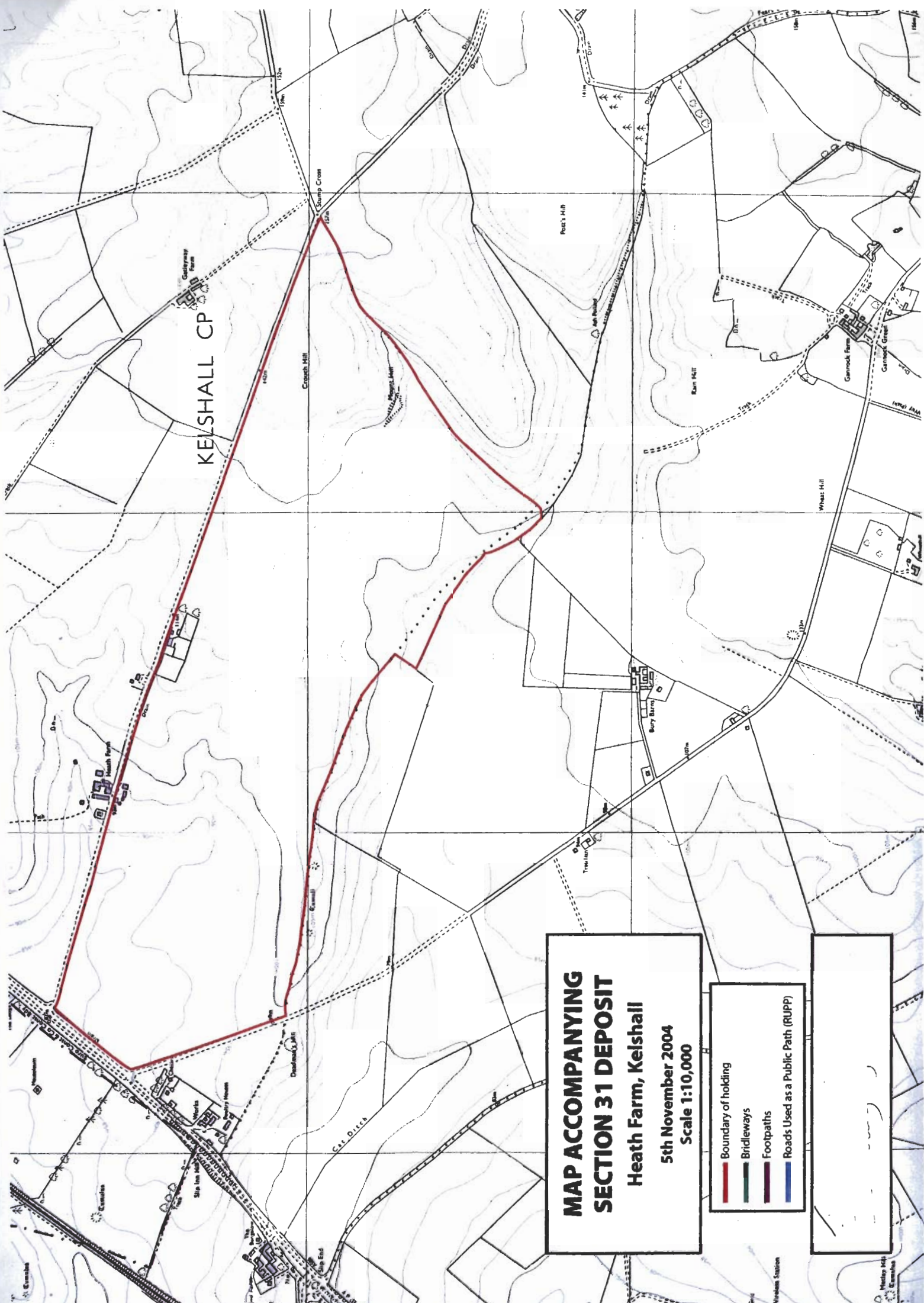

STATUTORY DECLARATION
