STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

WE DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. We are and have been since 1st June 1999 the owners of the land known as Prior's Wood more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. On the 14th day of 7th, 2000 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths. No other ways had been dedicated as highways over our property.
- 3. On the 4th day of August, 2000 we deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated 4th August, 2000 stating that no additional ways had been deposited as bridleways or footpaths since the deposit of the Statement referred to in 2. Above.
- 4. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 14th Tuly 2000 and at the present time we have no intention of dedicating any more public rights of way over our property.


