AND SINCERELY DECLARE as follows:

- 1 The Chancellor, Masters and Scholars of the University of Oxford are, and have been since 1938, the owners of the land known as The Hoo Estate more particularly delineated on the plans accompanying this Declaration and thereon edged red.
- 2 On the 21st day of January 1997 I, T del Nevo Esq, deposited with Hertfordshire County Council, being the appropriate Council, a Statement accompanied by plans delineating our property by red edging which stated that the ways shown on the said plans and detailed on the accompanying Statement and the plans and Statement accompanying this Declaration were the only legal Public Rights of Way, no other ways had been dedicated over the property.
- 3 No additional ways have been dedicated over the land edged red on the plans accompanying this Declaration since the Statement dated 21 January 1997, referred to in 2 above and at the present time we have no intention of dedicating any more Public Rights of Way over our property.

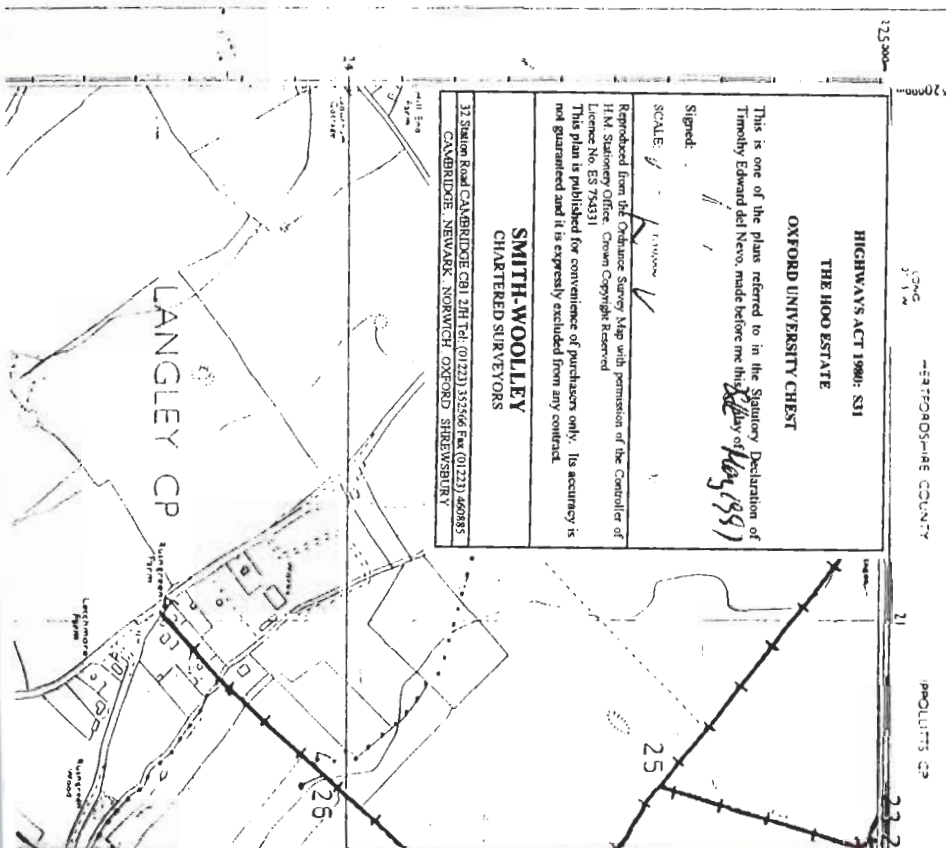
