## STATUTORY DECLARATION SECTION 31(6) of the HIGHWAYS ACT 1980

- 1. The University are and have been since 1938 the owner of the land known as The Hoo Estate more particularly delineated on the plan accompanying this declaration and thereon edged in red.
- 2. On the 21<sup>st</sup> day of January 1997 my predecessor in title, T del Nevo Esq, deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths, the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways, the ways coloured blue on the said plan and the plan accompanying this declaration had been dedicated as Restricted Byways no other ways had been dedicated as highways over my property.
