Kimpton Parish

Footpath 44

Commences from the County road in Peters Green east of the Post Office, thence north entering the estate and running northwest to the County road, south of Lawrence End Lodge.

Footpath 45

Commences from Footpath 44 north of Post Office, thence southeast to join Bridleway 51 northeast of church.

Footpath 54

Commences from County road northwest of Long Tom's Spring, thence northeast, north, northeast to join Whiteway Bottom land west of Rowdall's plantation.

Footpath 58

Commences from parish boundary at southern end of Hurst Wood, thence east along same, thence northeast to Whiteway Bottom lane.

Footpath 2

Commences from road south of Diamond End Cottages, thence west and northwest through Limekiln Wood to Lye Hill Road.

Footpath 3

Commences from County road on eastern side of Sloughs Wood, thence north along eastern side of same, thence northeast and north leaving land in _____'s ownership.

Footpath 4

Commences from Wandon Green Farm, thence north and northeast running along western edge of Sellbarns Dell, thence north to leave the land in _____'s ownership.

thence north along western side of same, thence northeast to join
County road opposite Long Toms Spring.

Footpath 3


Commences from County road on eastern side of Sloughs Wood, thence
north along western side of same, thence northeast and north
entering land in the Baileys Farm ownership east of the houses on
Lye Hill Road, thence north to join County road north of same.

Footpath 4

Commences from Wandon Green Farm, thence north and northeast
running along western edge of Sellsbarn Dell, thence north and
entering land in the ownership of the Baileys Farm Settlement,
thence north running along western edge of Baileys Close to join
County road south of Baileys Farm.

Footpath 21

Commencing from County road northwest of Whiteway Bottom, thence
northwest along field boundary, thence north and northwest to join
footpath 4 at southern tip of copse.
