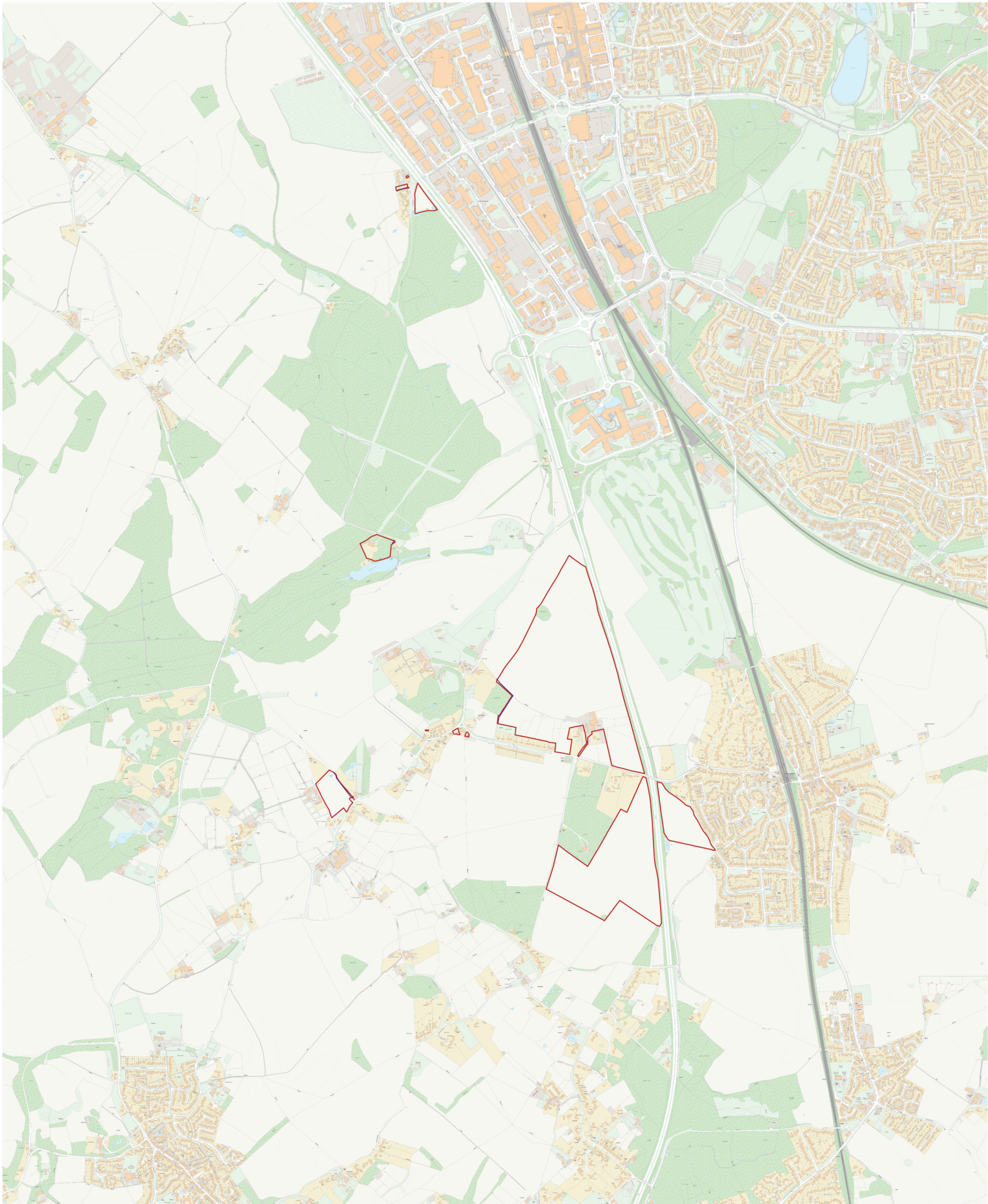

However, there were some ways shown purple on the map accompanying that statement that showed public footpaths.

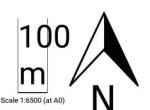


