STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, *h* DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 20th September 1984 the owner of the land known as **Westfield Farm, Westland Green, Little Hadham** more particularly delineated on the plan accompanying this declaration and thereon edged in **blue**.

2. On the day 12th of July 2010 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by **blue** edging which stated that the ways coloured **red** on the said plan and the plan accompanying this declaration had been dedicated as footpaths. The ways coloured **green** on the said plan and the plan accompanying this declaration had been dedicated as bridleways.

3. On the 20th of June 1995 I deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated 20th of June 1995, stating that no additional ways [other than those marked in the appropriate colour on the plan accompanying this declaration] had been dedicated as **footpaths, bridleways or restricted byways** since the deposit of the statement referred to in 2 above.

4. No additional ways have been dedicated over land edged **blue** on the plan accompanying this declaration since the statement dated 12th of July 2010 referred to in 2 above other than those footpaths and bridleway marked in the appropriate colour on the plan accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

I make this solemn declaration on the day 12th of July 2010 conscientiously believing it to be true and by virtue of the Statutory Declaration Act 1835.
