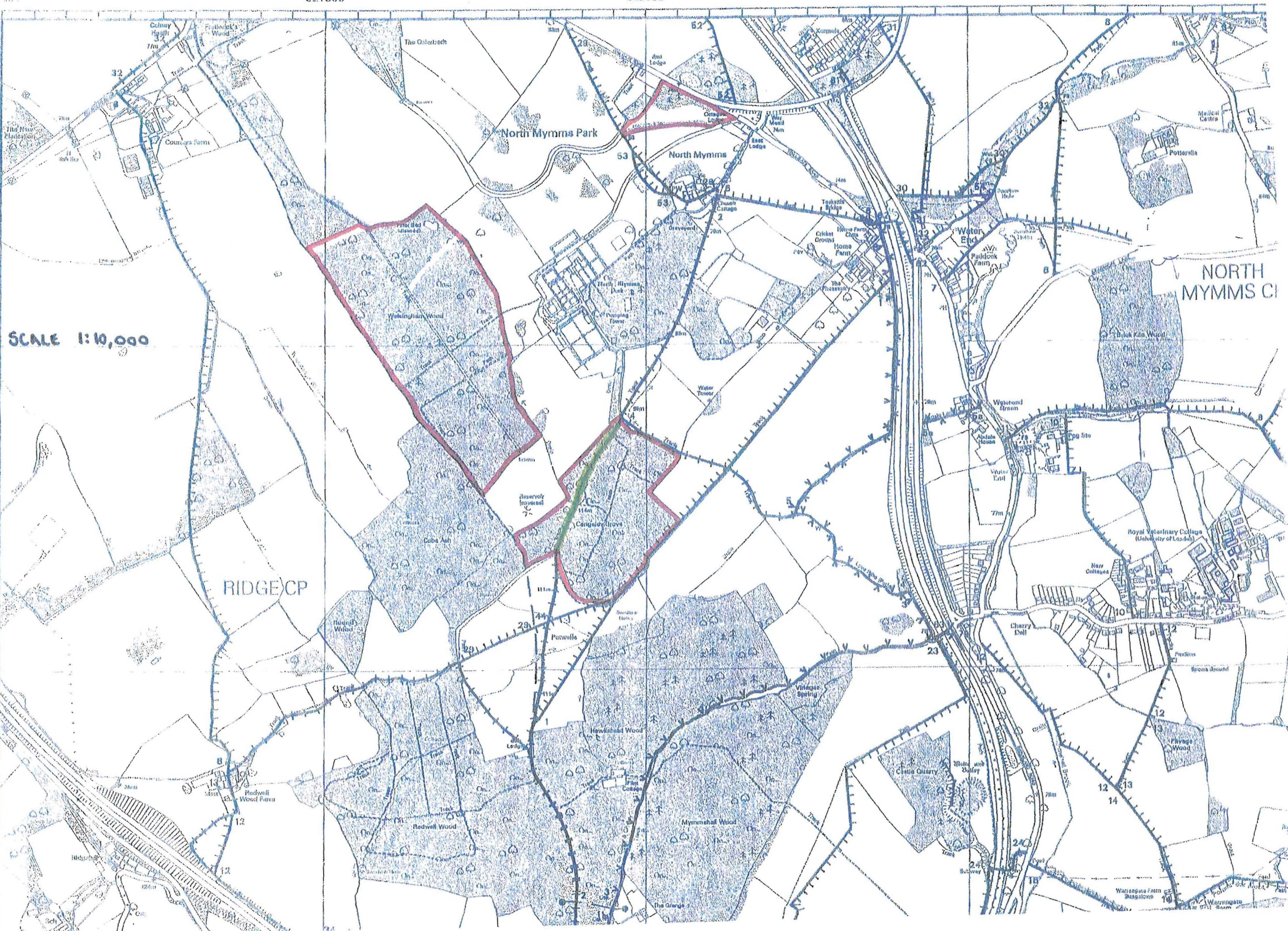

SECTION 31(6) of the HIGHWAYS ACT 1980

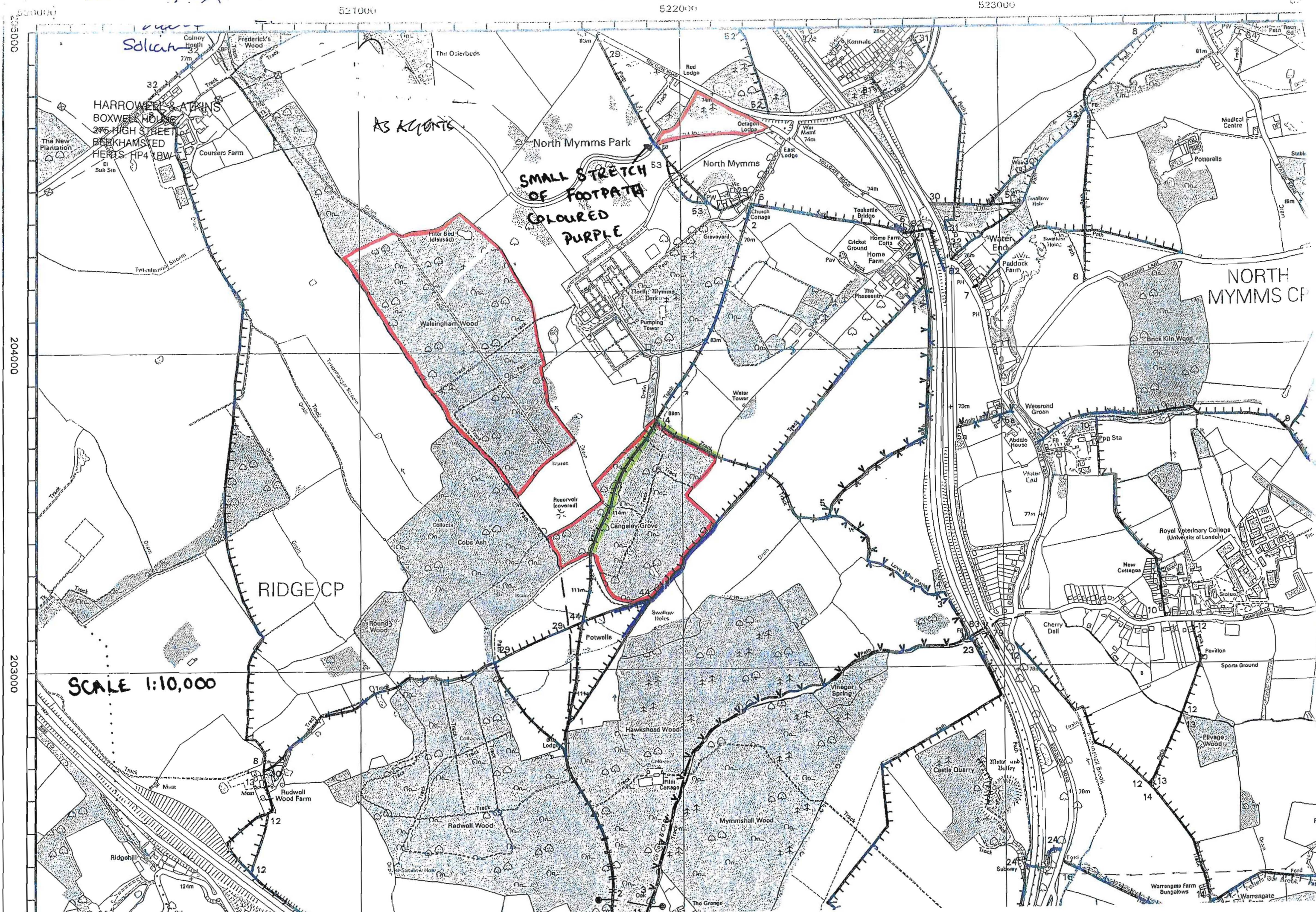
