## STATUTORY DECLARATION

### SECTION 31(6) OF THE HIGHWAYS ACT 1980

I CHRISTOPHER GERALD WRIGHT of Challoner House, 19 Clerkenwell Close, London EC1R 0RR [Landowner]

DO SOLEMNLY AND SINCERELY DECLARE as follows :

1. I am a Trustee of Mrs C Horton 1974 Discretionary Settlement. The Trustees of Mrs C Horton 1974 Discretionary Settlement (the Trustees) have been since 5th May 1987 the owner of the land known as PARSONAGE FARM, HATFIELD, HERTFORDSHIRE ("the Property") more particularly delineated on the plan accompanying this declaration and thereon edged red ("the Plan").
2. On or about the 23rd May 1997 the Trustees deposited with Hertfordshire County Council being the appropriate Council, a statement accompanied by a plan delineating the property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths and no other ways had been dedicated as highways over the property.
3. Two additional ways have been dedicated over the land edged red on the Plan accompanying this declaration since the statement dated 20th May 1997 referred to in 2 above these being:
  - (a) A Road used as a Public Path (hereinafter referred to as a "RUPP") as indicated at number 22 on the Plan.
  - (b) A second RUPP as indicated at number 23 on the Plan.
4. It is confirmed that at the present time the Trustees have no intention of dedicating any more public rights of way over the Property.

AND I MAKE this solemn declaration on the 4<sup>th</sup> day of June 2008 conscientiously believing it to be true and by virtue on the Statutory Declarations Act 1835.

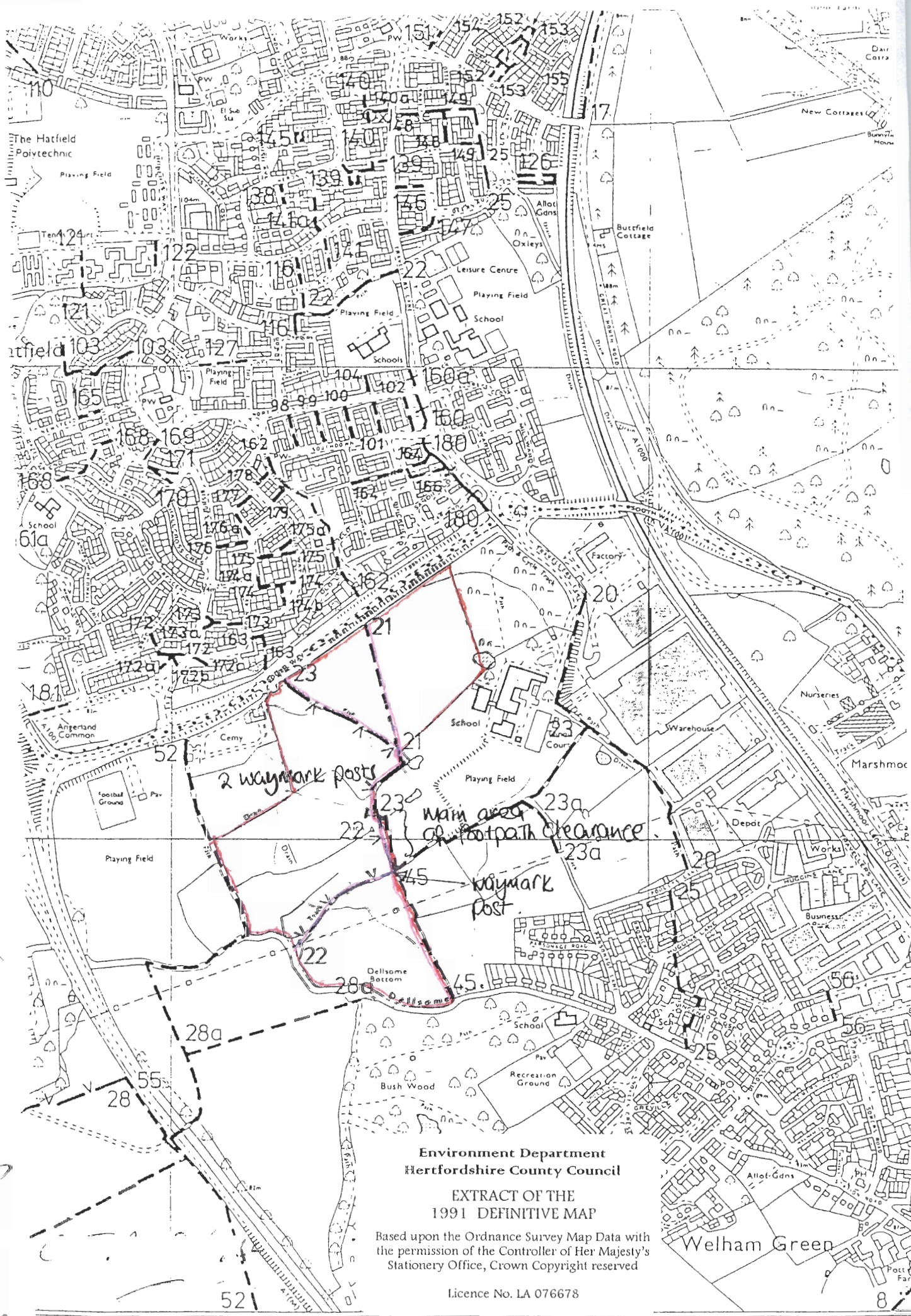
