

STATUTORY DECLARATION

of

We, _____ and _____

do solemnly and sincerely declare as follows:

1. We are and have been since 26 June 1997 the owners of the land known as Tollgate Farm, Colney Heath, more particularly delineated on the plans marked IFCS1A and IFCS1B accompanying this declaration and thereon edged in red.
2. On 20 June 2007 we deposited with Hertfordshire County Council, being the appropriate council, a statement accompanied by a plan delineating our property by red edging. This statement stated that the ways coloured purple on the said plan, and the plan accompanying this declaration, had been dedicated as footpaths and the way coloured orange had been recorded on the Definitive Map as an RUPP. The statement went on to say that we did not accept that the map and statement were correct and we had applied under s.53 of the Wildlife and Countryside Act 1981 to Hertfordshire County Council for a Modification Order to be made to classify the way coloured orange as a footpath. No other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 20 June 2007 referred to

in 2. above and at the present time we have no intention of dedicating any more public rights of way over our property.

AND we make this solemn declaration conscientiously believing the same to be true and by virtue of the Statutory Declarations Act 1835.

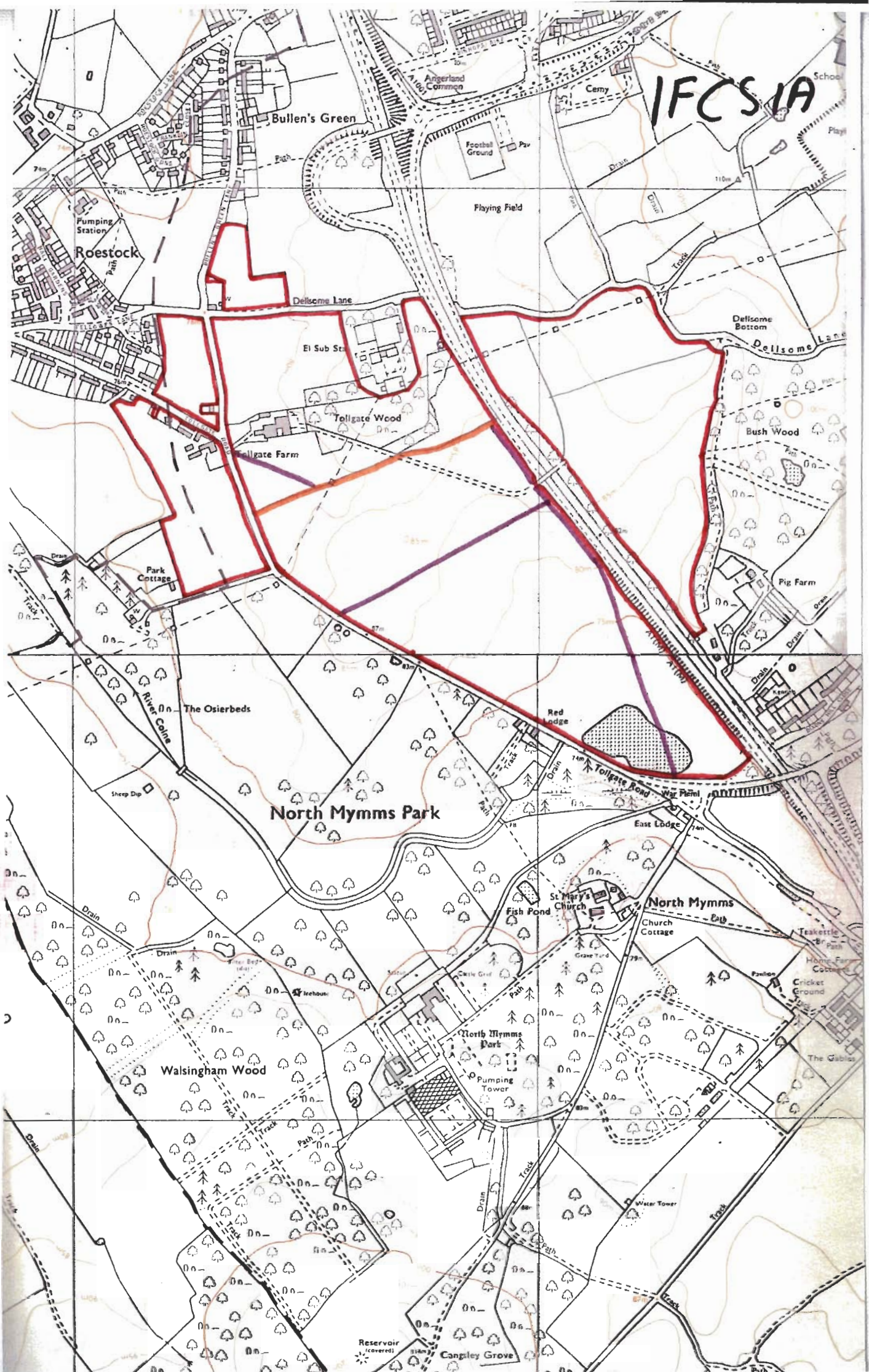

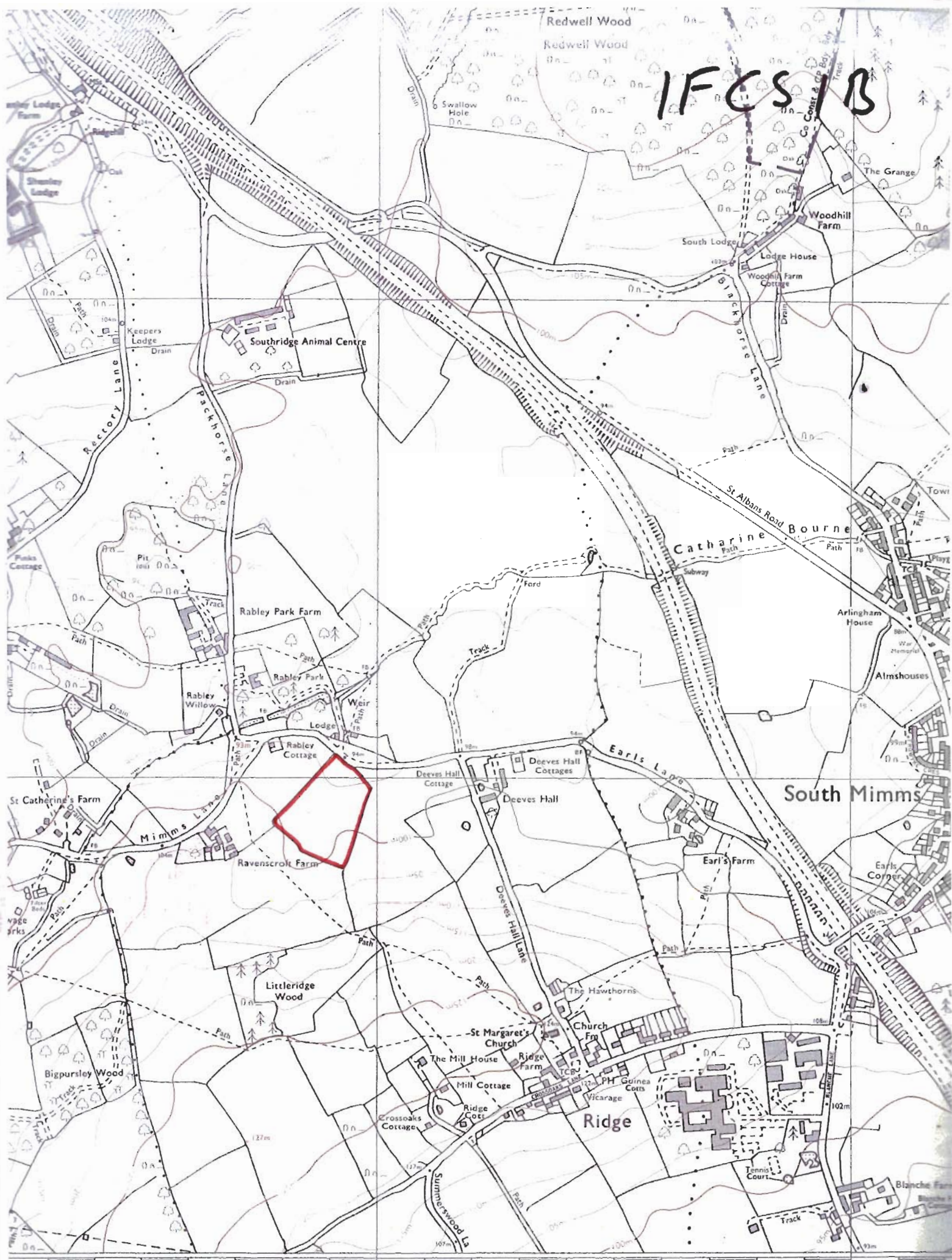

2. The aforementioned land lies in the Parishes of Colney Heath North Mymms Ridge
- 3* The ways coloured purple on the said plan have been dedicated as footpaths

- ~~5* The ways coloured brown on the said plan have been dedicated as highways with vehicular status (Byway Open to All Traffic or BOAT)~~
- ~~6* The ways coloured blue on the said plan have been dedicated as highways with at least bridleway rights which may have possible vehicular rights (Road Used as Public Path or RUPP)~~
7. No other ways over the land have been dedicated as highways
