- 2. On 20 June 2007 we deposited with Hertfordshire County Council, being the appropriate council, a statement accompanied by a plan delineating our property by red edging. This statement stated that the ways coloured purple on the said plan, and the plan accompanying this declaration, had been dedicated as footpaths and the way coloured orange had been recorded on the Definitive Map as an RUPP. The statement went on to say that we did not accept that the map and statement were correct and we had applied under s.53 of the Wildlife and Countryside Act 1981 to Hertfordshire County Council for a Modification Order to be made to classify the way coloured orange as a footpath. No other ways had been dedicated as highways over our property.
- No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 20 June 2007 referred to

in 2. above and at the present time we have no intention of dedicating any more public rights of way over our property.




