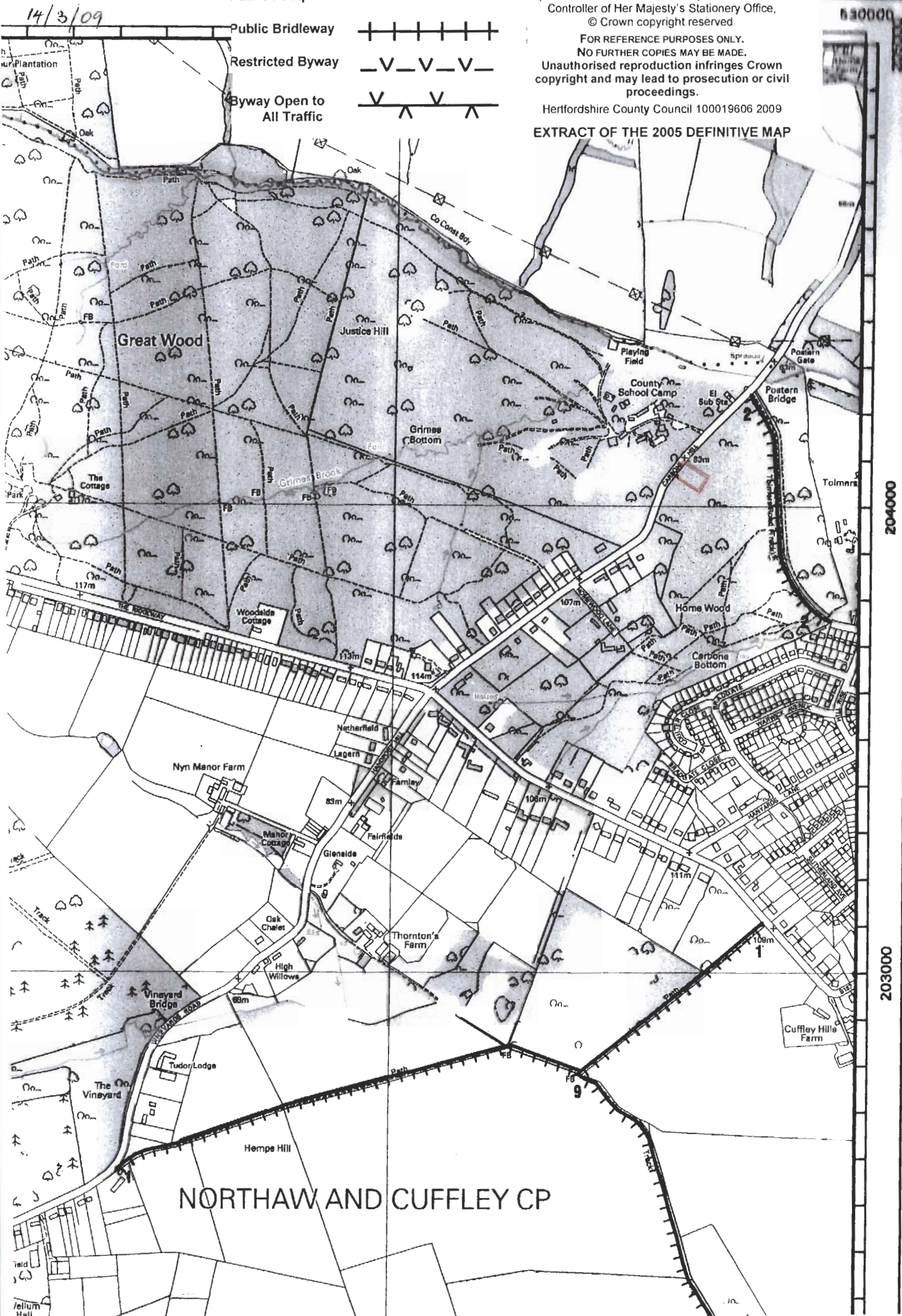
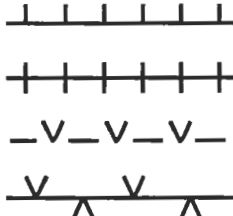
EXTRACT OF THE 2005 DEFINITIVE MAP

STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, Rosemary Sheila Tomlinson DO SOLEMNLY AND SINCRELY DECLARE as follows:
