

## STATUTORY DECLARATION

### SECTION 31(6) of the HIGHWAYS ACT 1980

I John Reeve DO SOLEMNLY and SINCERELY DECLARE as follows.

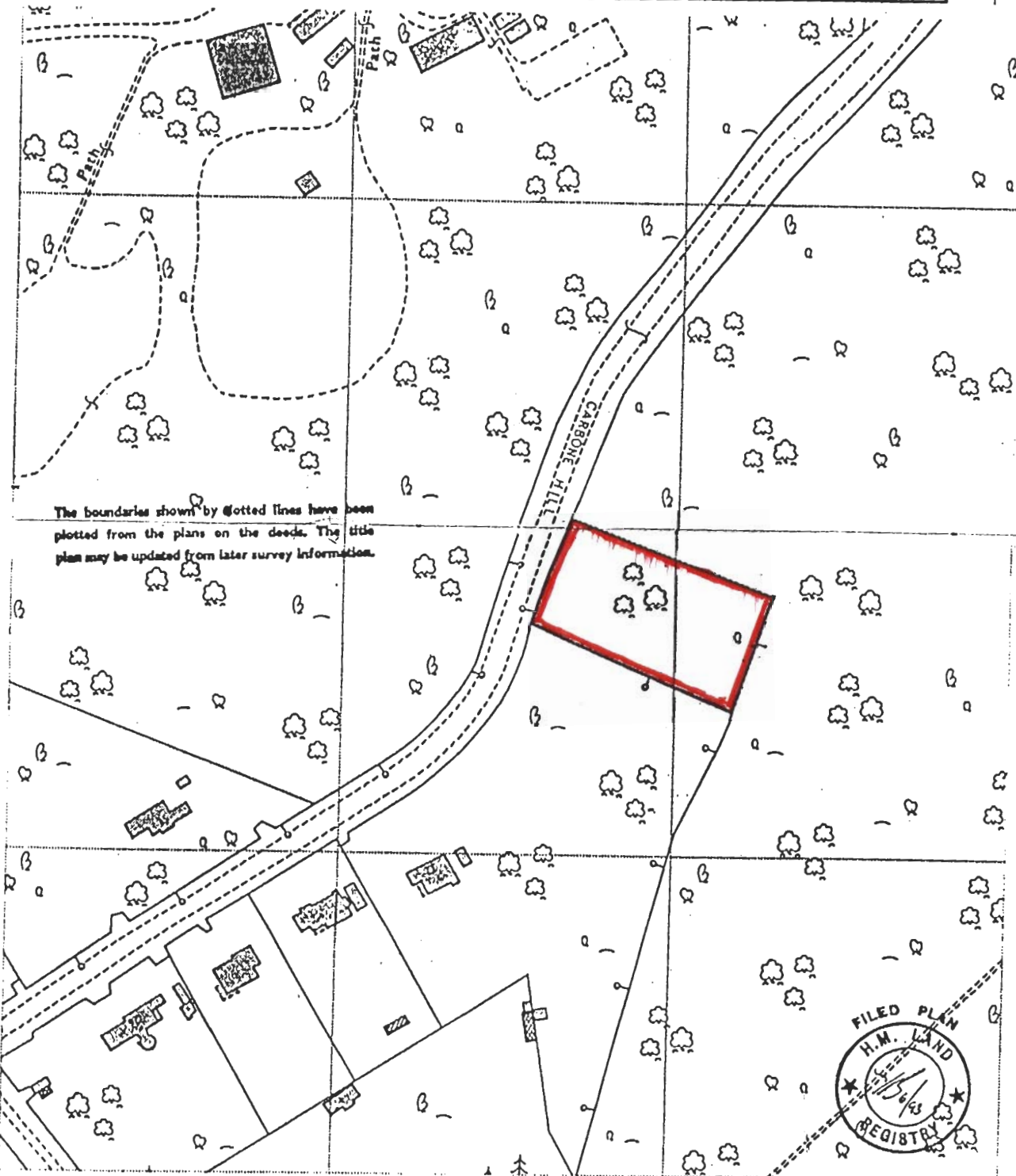
