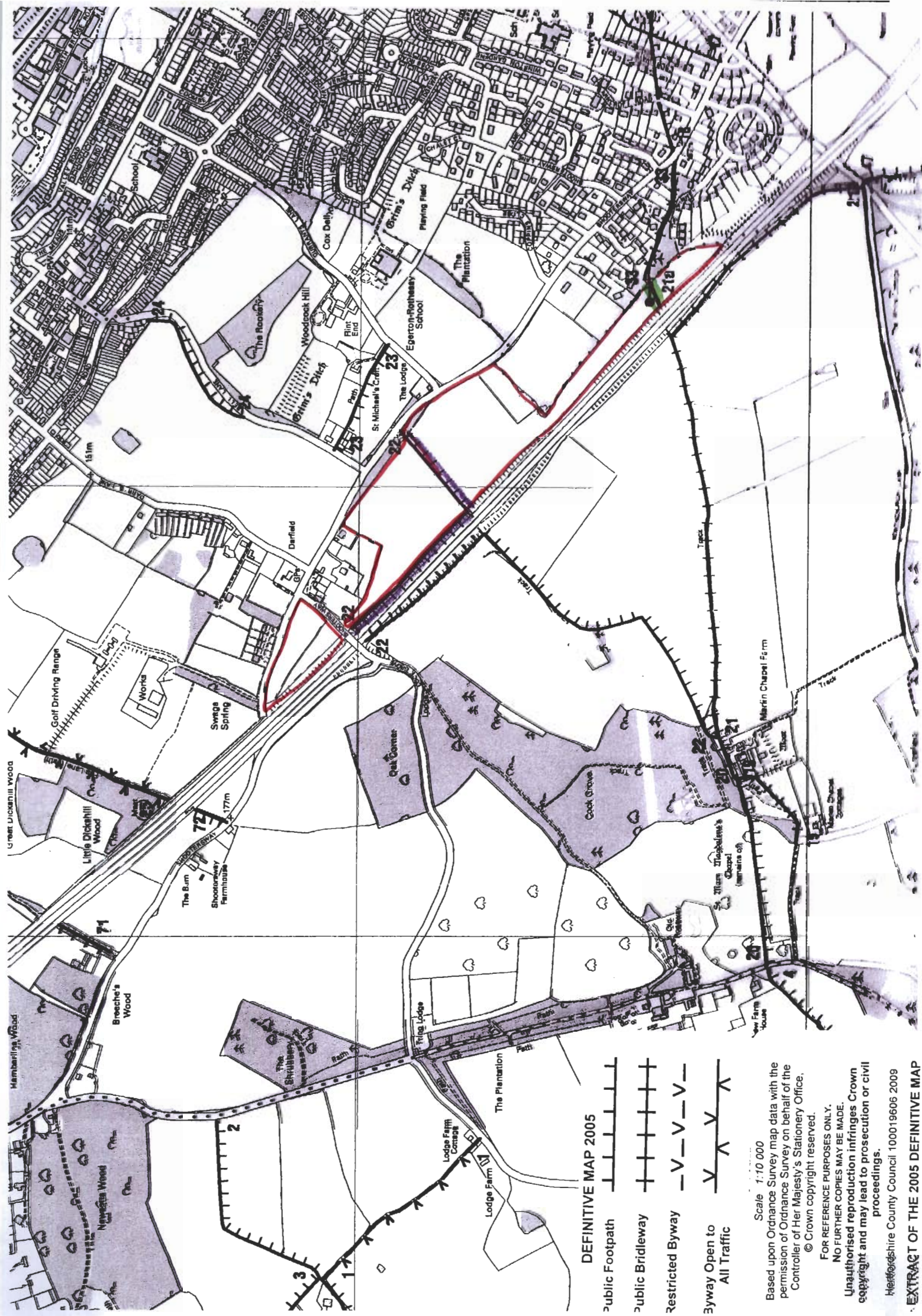

EXTRACT OF THE 2005 DEFINITIVE MAP

STATUTORY DECLARATION
SECTION 31(6) of the HIGHWAYS ACT 1980

I, Nigel Hadden-Paton, DO SOLEMNLY SWEAR AND SINCERELY DECLARE as follows:

1. I am and have been since 1983 the owner of the land known as *Shootersway Farmland* more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the 14th day of April 2009 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths and the way coloured green on the said plan and the plan accompanying this declaration had been dedicated as a bridleway. No other ways had been dedicated as highways over my property.
3. On the 14th day of the April 2009 I deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration date 14/4/09 stating that no additional ways other than those marked in the appropriate colour on the plan accompanying this declaration had been dedicated as footpaths or bridleways since the deposit of the statement referred to in 2 above.
4. No additional ways have been dedicated over land edged in red on the plan accompanying this declaration since the statement dated referred to in 2 above other than those footpaths or bridleways marked in the appropriate colour on the plan accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
