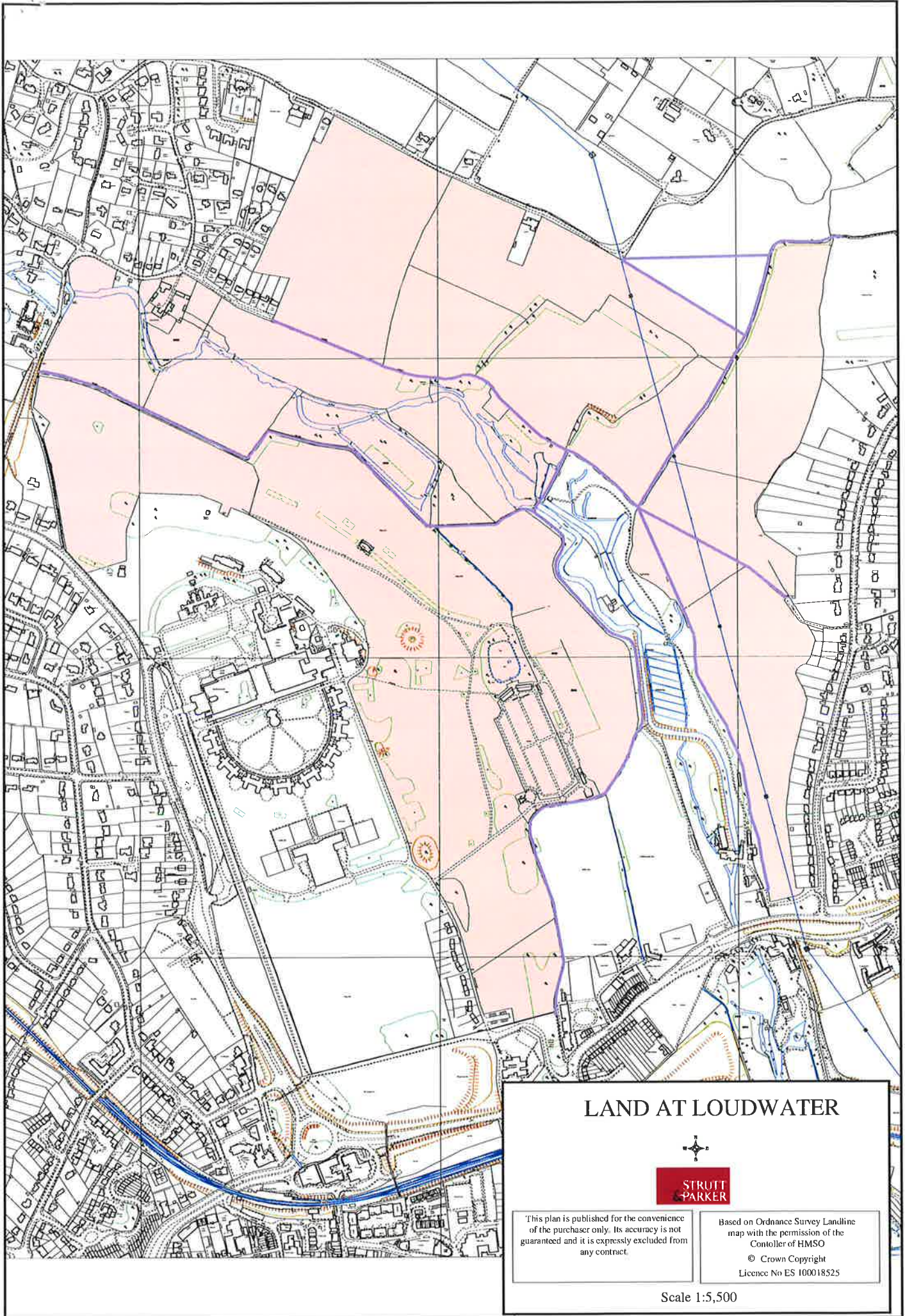
Fair Processing Notice
