

STATUARY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, _____, DO SOLEMNLY AND SINCERELY DECLARE:-

1. I am and have been since 19th May 1958, jointly with James Robin Streather (deceased), the owner of the land known as Shaw Green Farm, Rushden, more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the 27th November 1995 I, or my predecessor in title, James Robin Streather, deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths, the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways, the ways coloured brown on the said plan and the plan accompanying this declaration had been dedicated as Byway open to all Traffic, the ways coloured blue on the said plan and the plan accompanying this declaration had been dedicated as Roads used as Public paths. No other ways had been dedicated as highways over my property.
3. On the 27th November 1995 I, or my predecessor in title, James Robin Streather, deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated 27th November 1995 stating that no additional ways, other than those marked in the appropriate colour on the plan accompanying this declaration, had been dedicated since the deposit of the statement referred to in 2 above.
4. No additional ways have been dedicated over land edged red on the plan accompanying this declaration since the statement dated 27th November 1995 referred to in 2 & 3 above and at the present time I have no intention of dedicating any more public rights of way over my property.



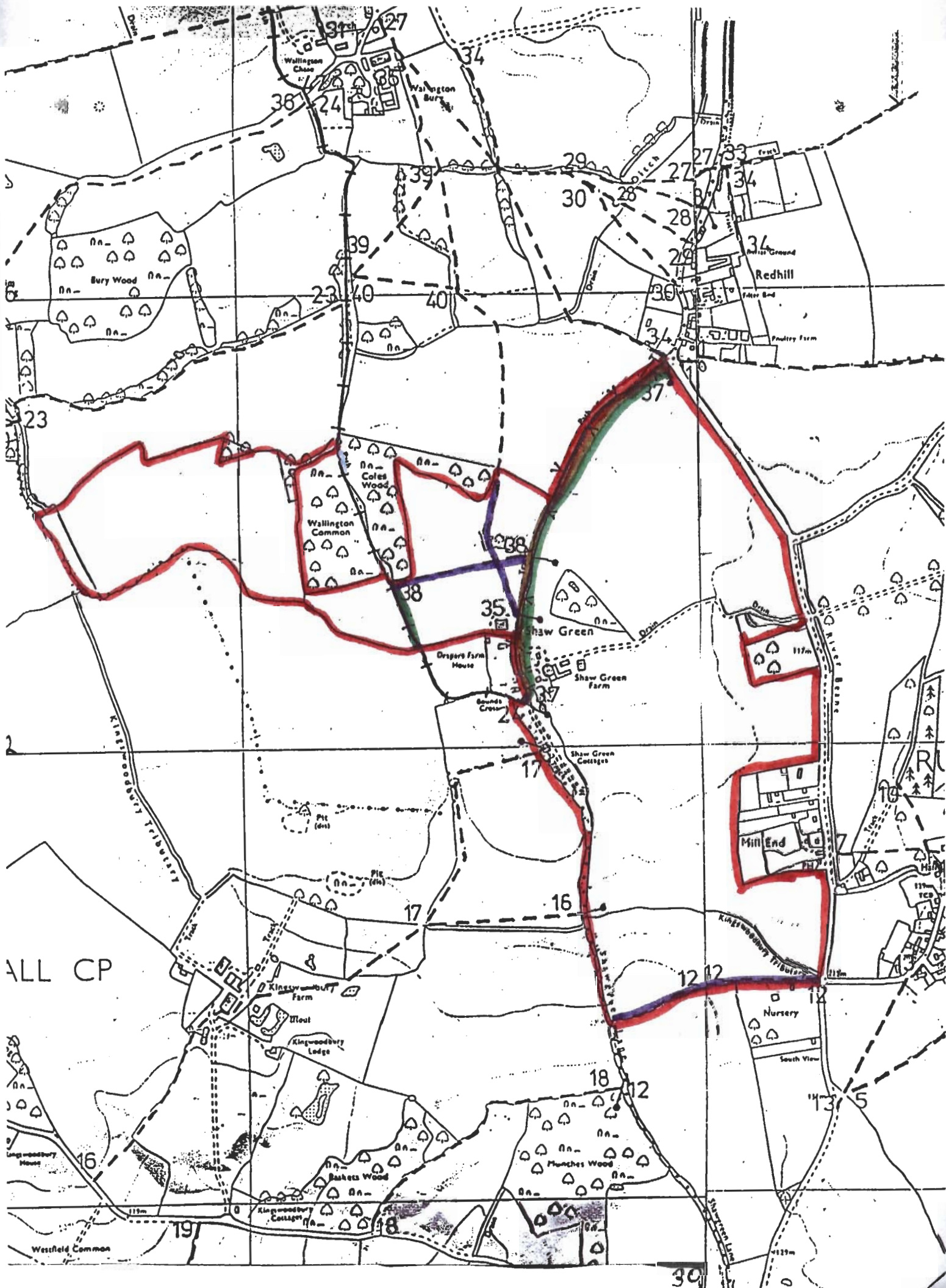

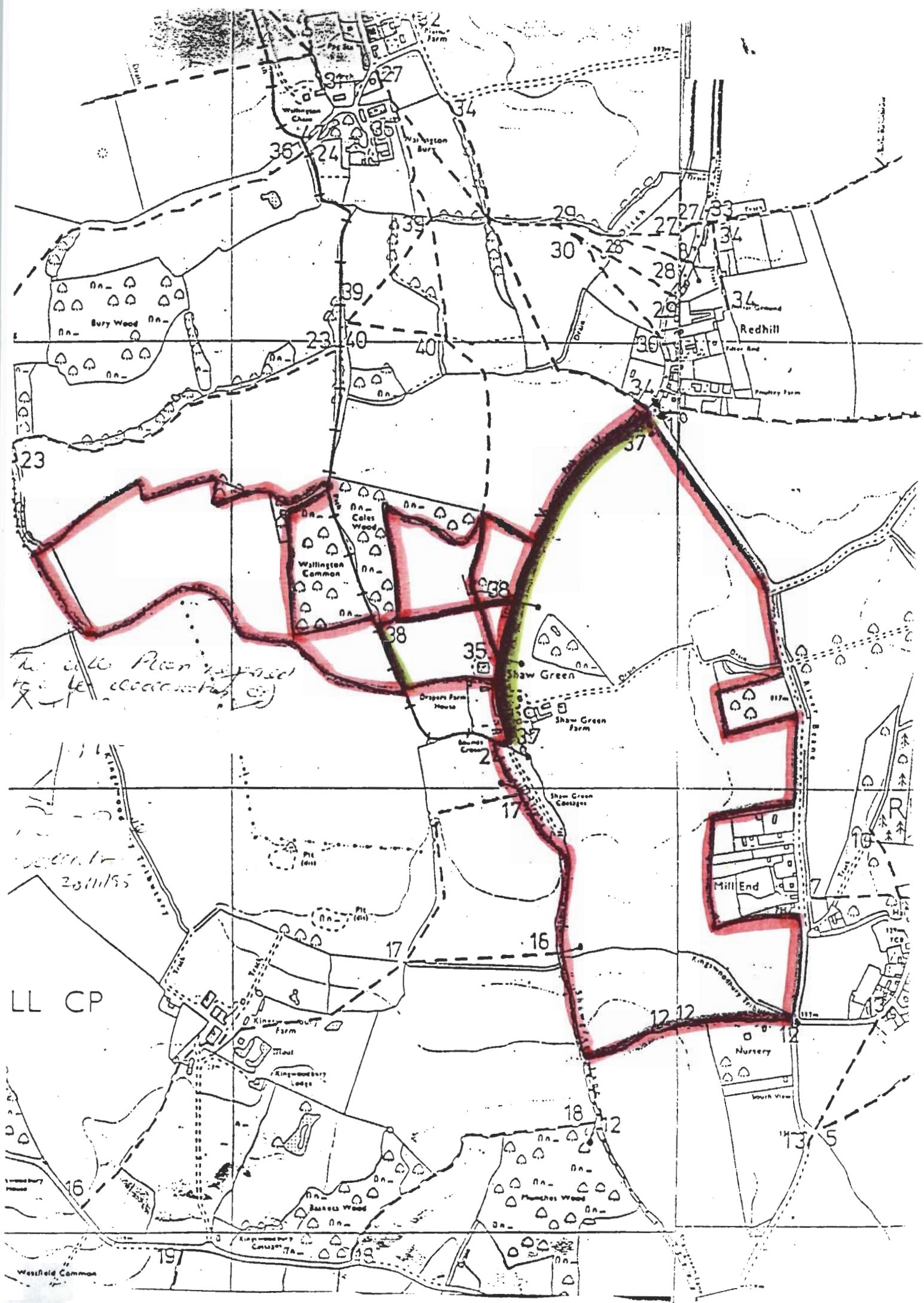

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I
follows.

SOLEMNLY AND SINCERELY DECLARE as

1. I am and have been since 19 May 1958 the owner of the land known as Shaw Green Farm more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the 27th day of November 1995 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that :-
 - a) the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as Highways with vehicular status.
 - b) the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as Bridleways.
 - c) the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as Footpaths.
 - d) no other ways had been dedicated as Highways over my property.
3. On the 27th day of November 1995 I deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated 27th November 1995, stating that no additional ways had been dedicated since the deposit of the Statement referred to in 2 above.
4. No additional ways have been dedicated over the land edged in red on the plan accompanying this declaration since the Statement dated 14th November 1995 referred to in 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.

And I make this solemn declaration on the 27th day of November 1995 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.
