



**DEPOSIT OF STATEMENT AND PLAN
SECTION 31(6) OF THE HIGHWAYS ACT 1980**

1. I am and have been since 1st December 1979 the owner of the land known as Sandon Bury more particularly delineated on the two plans accompanying this declaration and thereon edged in red.
2. The aforementioned land lies in the Parishes of Sandon, Rushden, Kelshall & Therfield
3. The ways coloured purple on the said plans have been dedicated as footpaths
4. The ways coloured green on the said plans have been dedicated as bridleways
5. The ways coloured blue on the said plans have been dedicated as Restricted Byways
6. The ways coloured brown on the said plans have been dedicated as highways with vehicular status (Byway Open to All Traffic or BOAT) *
7. No other ways over the land have been dedicated as highways

STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, Edward William Faure Walker DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 1st December 1979 the owner of the land known as Sandon Bury Farm more particularly delineated on the two plans accompanying this declaration and thereon edged in red.
2. On the day 13th day of April 2004 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the two plans accompanying this declaration had been dedicated as footpaths, the ways coloured green on the said plan and the two plans accompanying this declaration had been dedicated as Bridleways, the ways coloured blue on the said plan and the two plans accompanying this declaration had been dedicated as Restricted Byways, the ways coloured brown on the said plan and the two plans accompanying this declaration had been dedicated as Byways Open to All Traffic; no other ways have been dedicated as highways over my property.
3. On the 13th day of April 2004 I deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated 1st April 2004, stating that no additional had been dedicated as footpaths, bridleways, Restricted Byways, Byways Open to All Traffic since the deposit of the statement referred to in 2 above.
4. No additional ways have been dedicated over land edged red on the two plans accompanying this declaration since the statement dated 13th day of April 2004 referred to in 2 above, since the date of the statutory declaration referred to in 3 above. I have no intention of dedicating any more public rights of way over my property.
