

**STATUTORY DECLARATION
SECTION 31(6) of the HIGHWAYS ACT 1980**

1. We are and have been since 1951 the owner of the land known as Sandridgebury Farm more particularly delineated on the plan accompanying this declaration and thereon edged in red.


