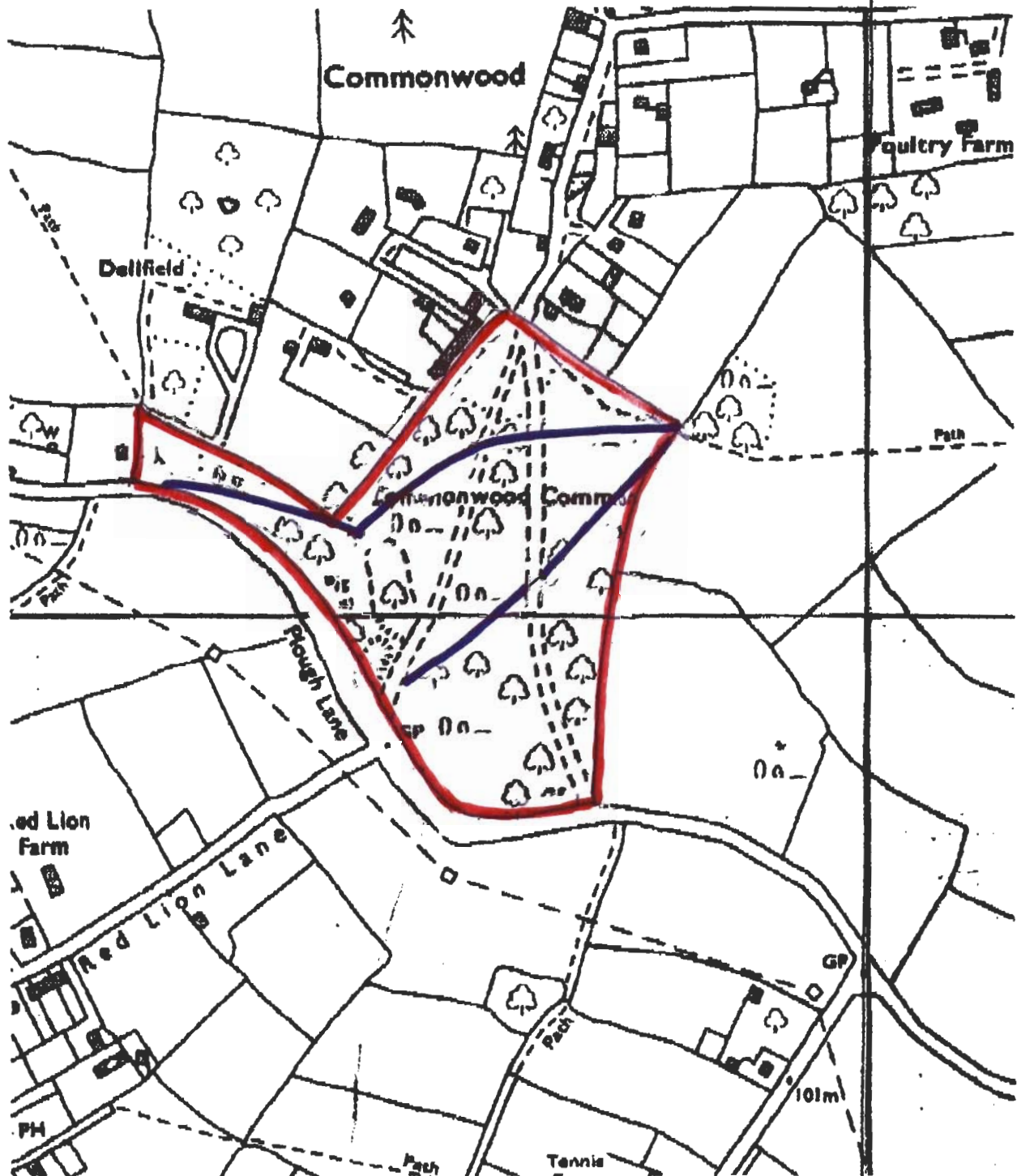

**STATUTORY DECLARATION
UNDER SECTION 31(6) OF THE HIGHWAYS ACT 1980**

AND I MAKE this solemn declaration on the 6th day of October 2004 conscientiously believing the same to be true and by virtue of the Statutory Declarations Act 1835

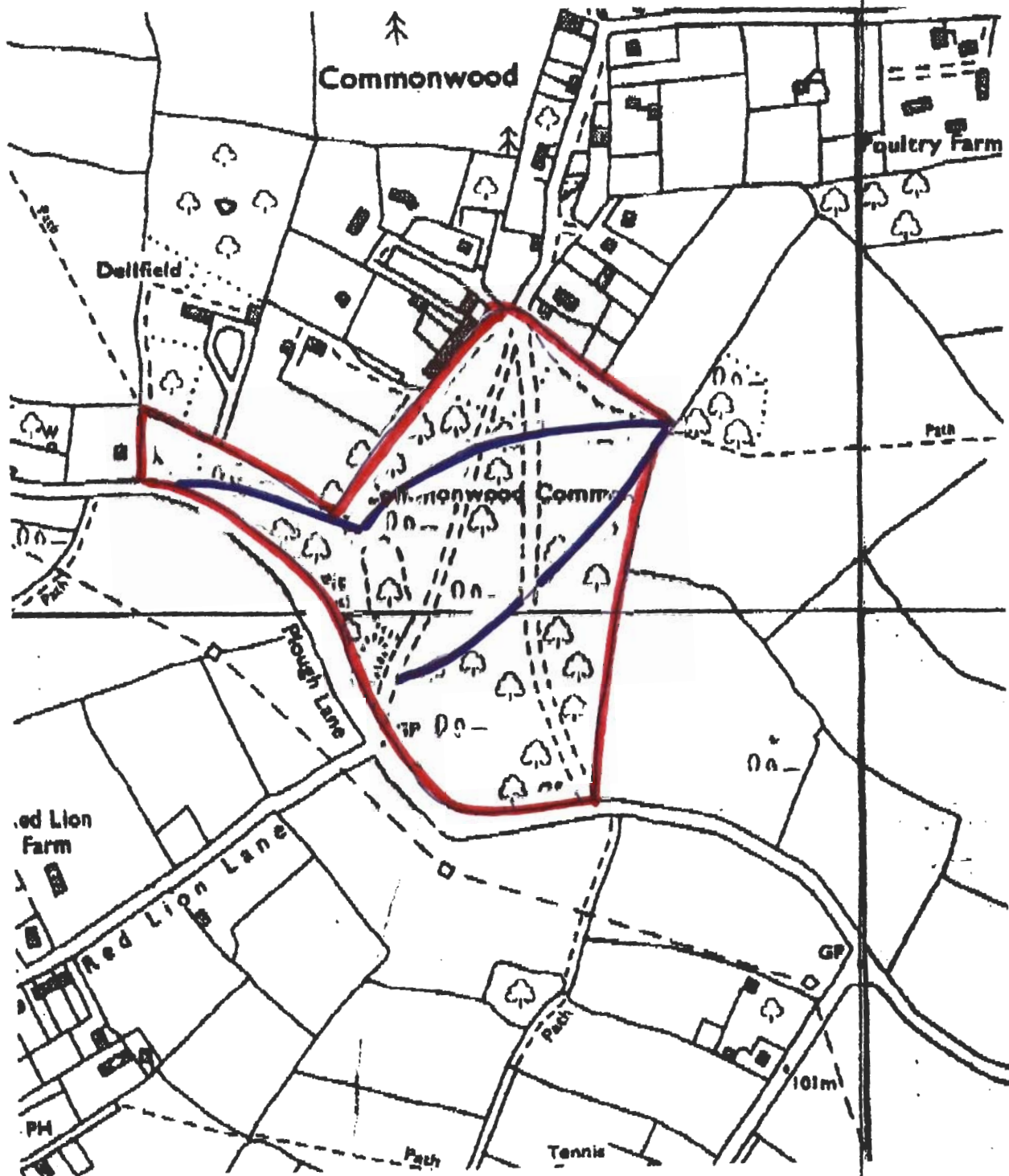
