

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 26<sup>th</sup> September 1986 the owner of the land known as Harrocks Wood, Rickmansworth, Herts particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 19<sup>th</sup> of May 1993, my predecessor, Laura Judson, deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths, no other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 19<sup>th</sup> May 1993, referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

AND I MAKE this solemn declaration on the 12<sup>th</sup> day of May, 1999 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

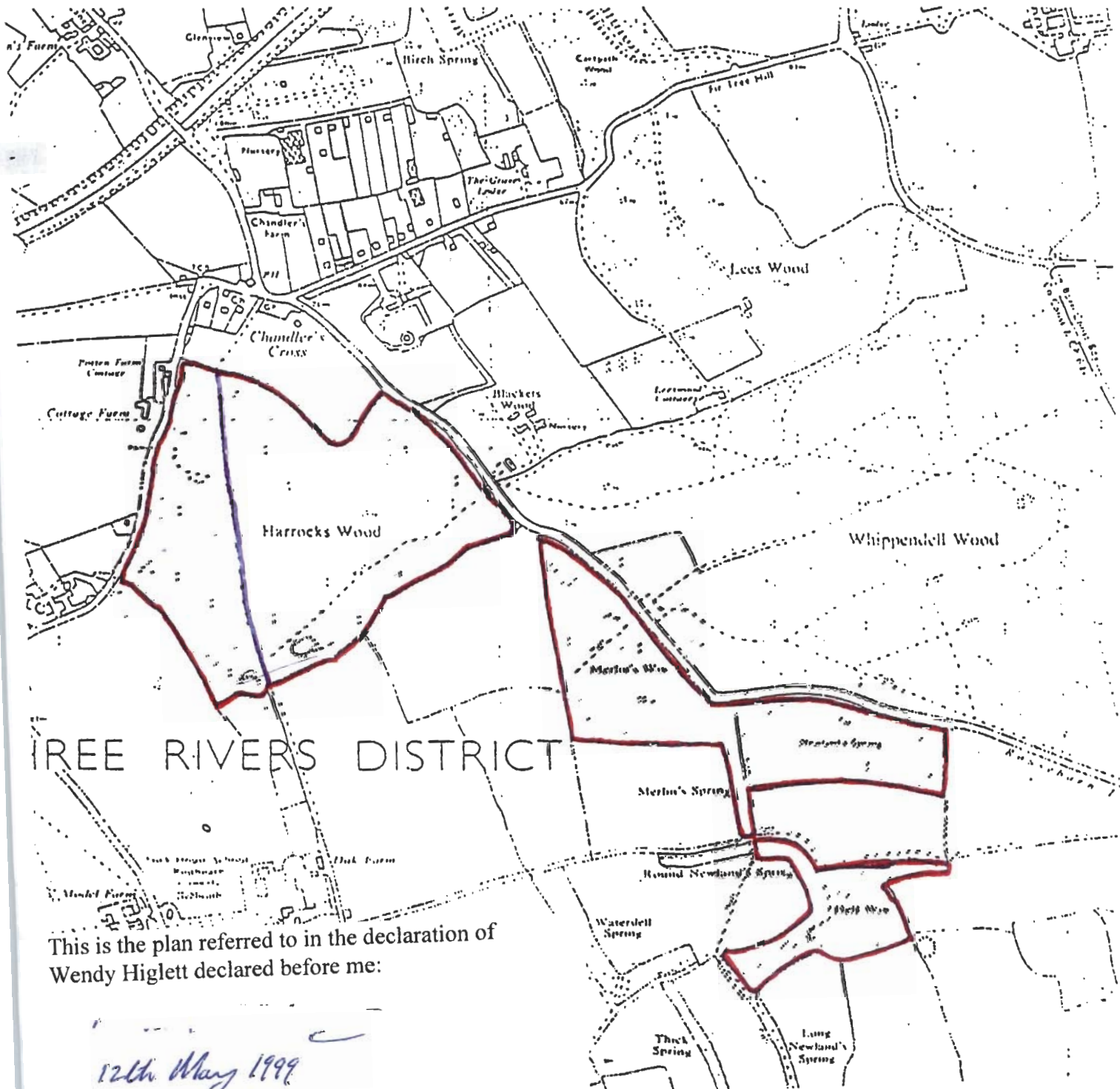

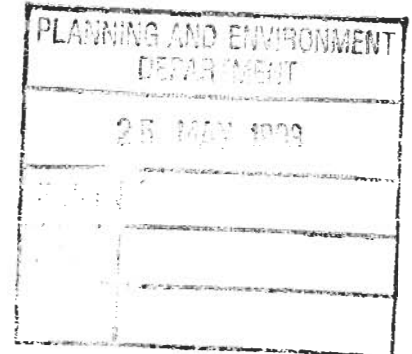

Highways Act 1980 - Section 31 (6)  
Harrocks Wood, Rickmansworth, Herts

The Woodland Trust previously gave notice on 8 December 1986, as required by the above Act declaring those ways known to be public highways on the above property. It had been the Trust's aim to confirm its intention not to dedicate any further public highways over its property by depositing a Statutory Declaration to this effect within six years of the above date.

The Trust has continued to manage its property with this intention, but the six year period for submission of a Statutory Declaration has now elapsed, and the Trust is therefore resubmitting the attached notice. A Statutory Declaration will be deposited in accordance with the Highways Act procedure, within six years from today's date.

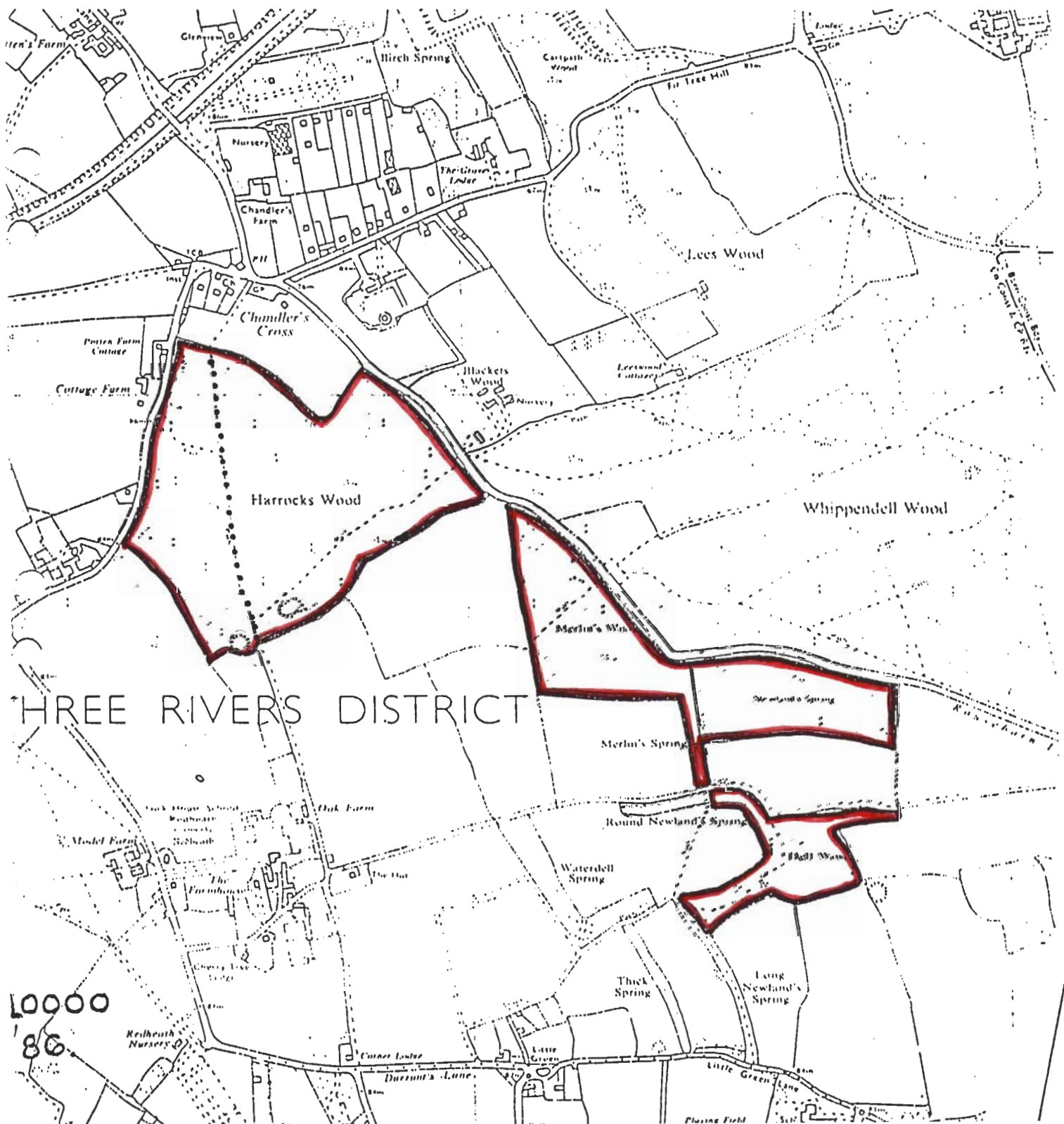
