STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, SIR SIMON BOWES LYON DO SOLEMNLY AND SINCERELY DECLARE as follows:

1.

I am the owner of the land known Pinfold and Hearnfield more particularly delineated on the plan accompanying this declaration and thereon edged in red.

2.

On the twenty fifth of November 2010 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths, the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways, the ways coloured blue on the said plan and the plan accompanying this declaration had been dedicated as Restricted Byways, the ways coloured brown on the said plan and the plan accompanying this declaration had been dedicated as Byways Open to All Traffic. No other ways had been dedicated as highways over my property.

On the twenty fifth of November 2010 I deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated twenty fifth of November 2010, stating that no additional ways other than those marked in the appropriate colour on the plan accompanying this declaration had been dedicated as footpaths, bridleways, Restricted Byways, Byways Open to All Traffic since the deposit of the statement referred to in 2 above.

No additional ways have been dedicated over land edged red on the plan MARKED SBL 1 accompanying this declaration since the statement dated twenty fifth of November 2010 referred to in 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.

AND I MAKE this solemn declaration on the day twenty fifth of November 2010 conscientiously believing it to be true and by virtue of the Statutory Declaration Act 1835.

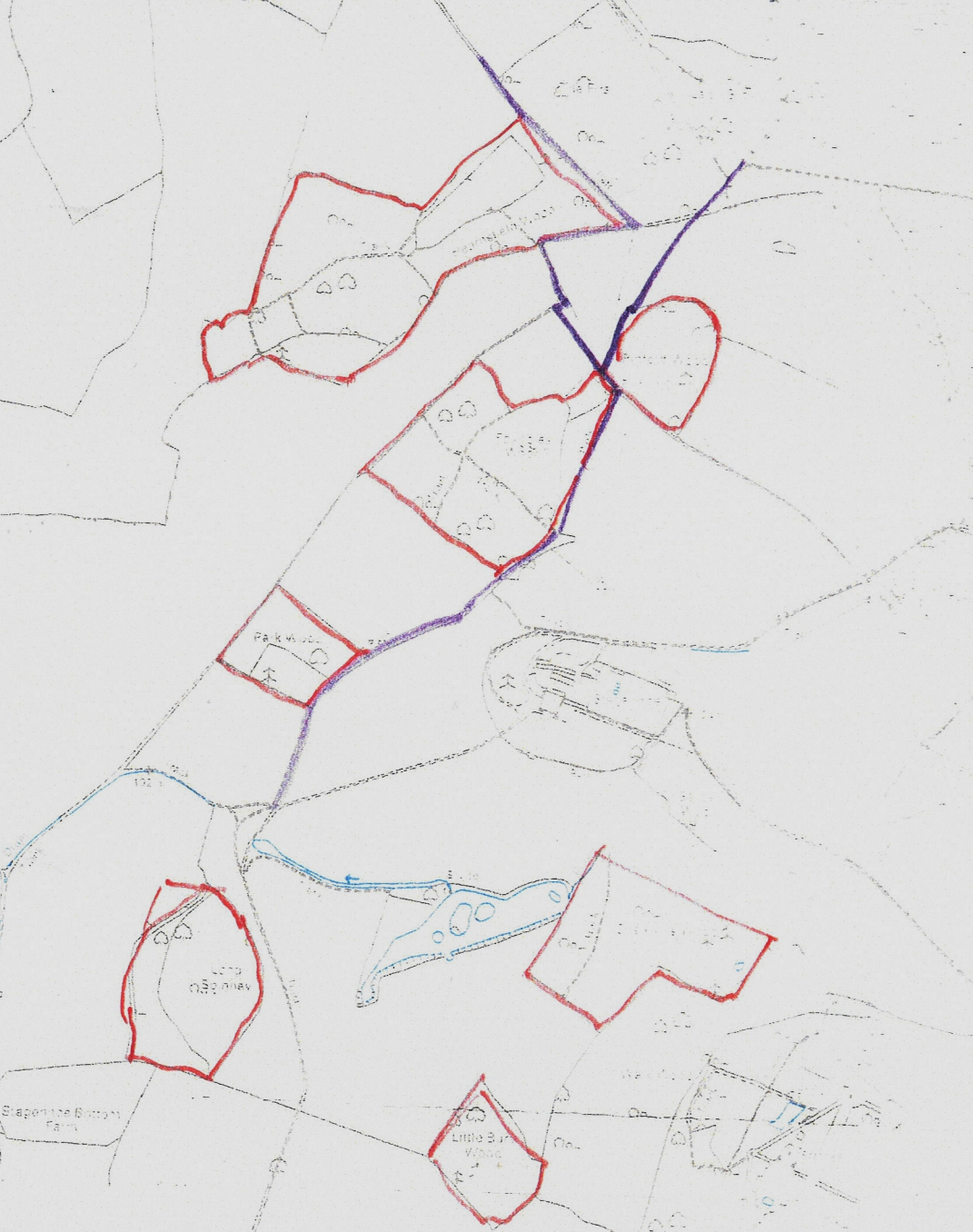
