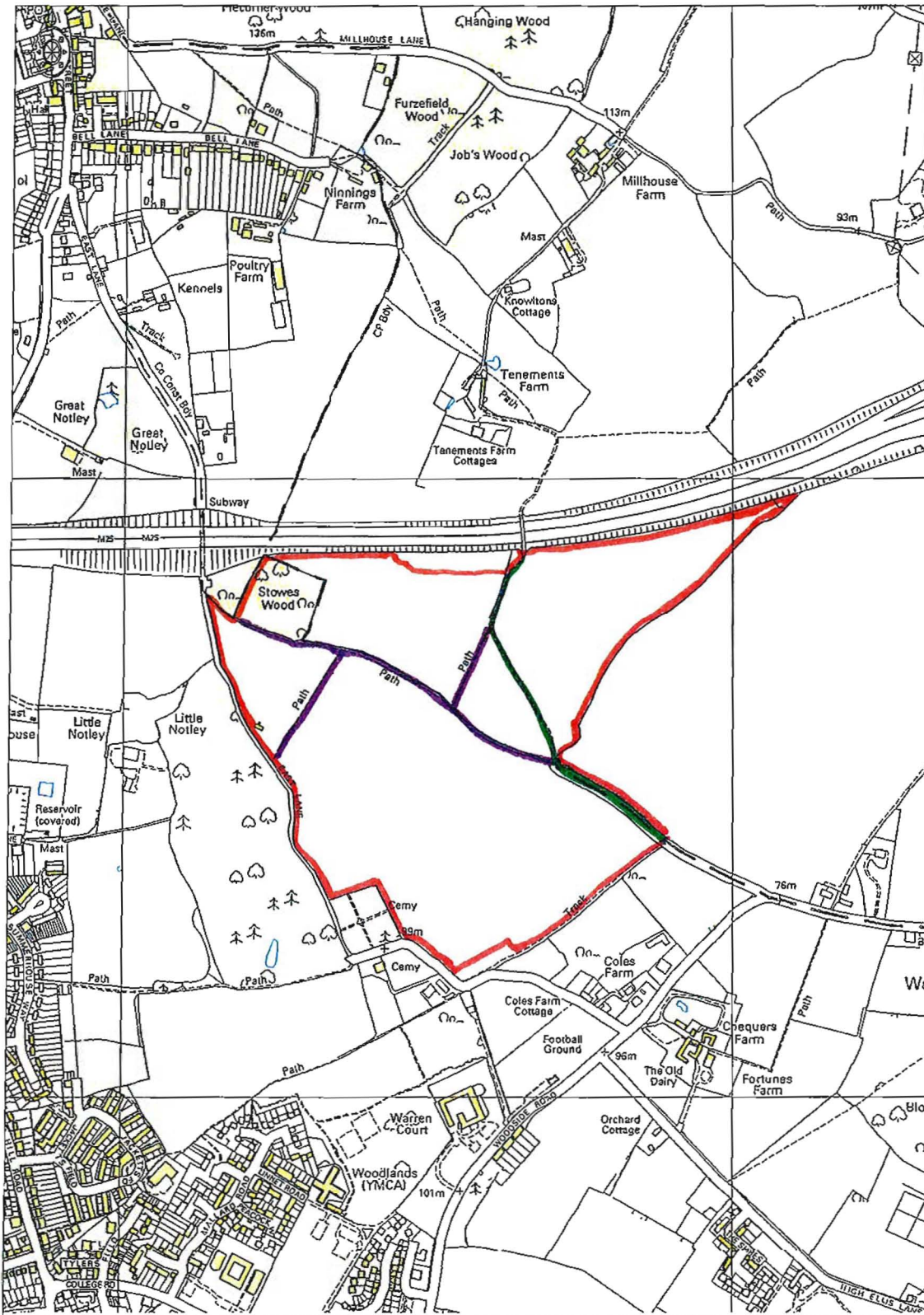

STATUTORY DECLARATION
SECTION 31(6) of the HIGHWAYS ACT 1980

I, Charles Edward Stephen Martin DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 24 November 1997 the owner of the land known as the land to the east of East Lane, Abbots Langley, Hertfordshire more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On the 8th day of the Nov 2012 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths and which stated that the ways coloured green on the said plan and the plan accompanying this declaration had been dedicated as bridleways.
