SECTION 31(6) of the HIGHWAYS ACT 1980

1. I am and have been since 12th October 2000 the owner of the land known as Marden Hill, more particularly delineated on the plan accompanying this declaration and thereon edged in red. **AND MARDEN "DM"**

On the 29th January 2003, I, _____, deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated: 29th January 2003 stating that no additional ways, other than those marked in the appropriate colour on the plan accompanying this declaration had been dedicated as *footpaths, *bridleways, *Byways Open to All Traffic, *Roads Used as Public Paths since the deposit of the statement referred to in 2. above.

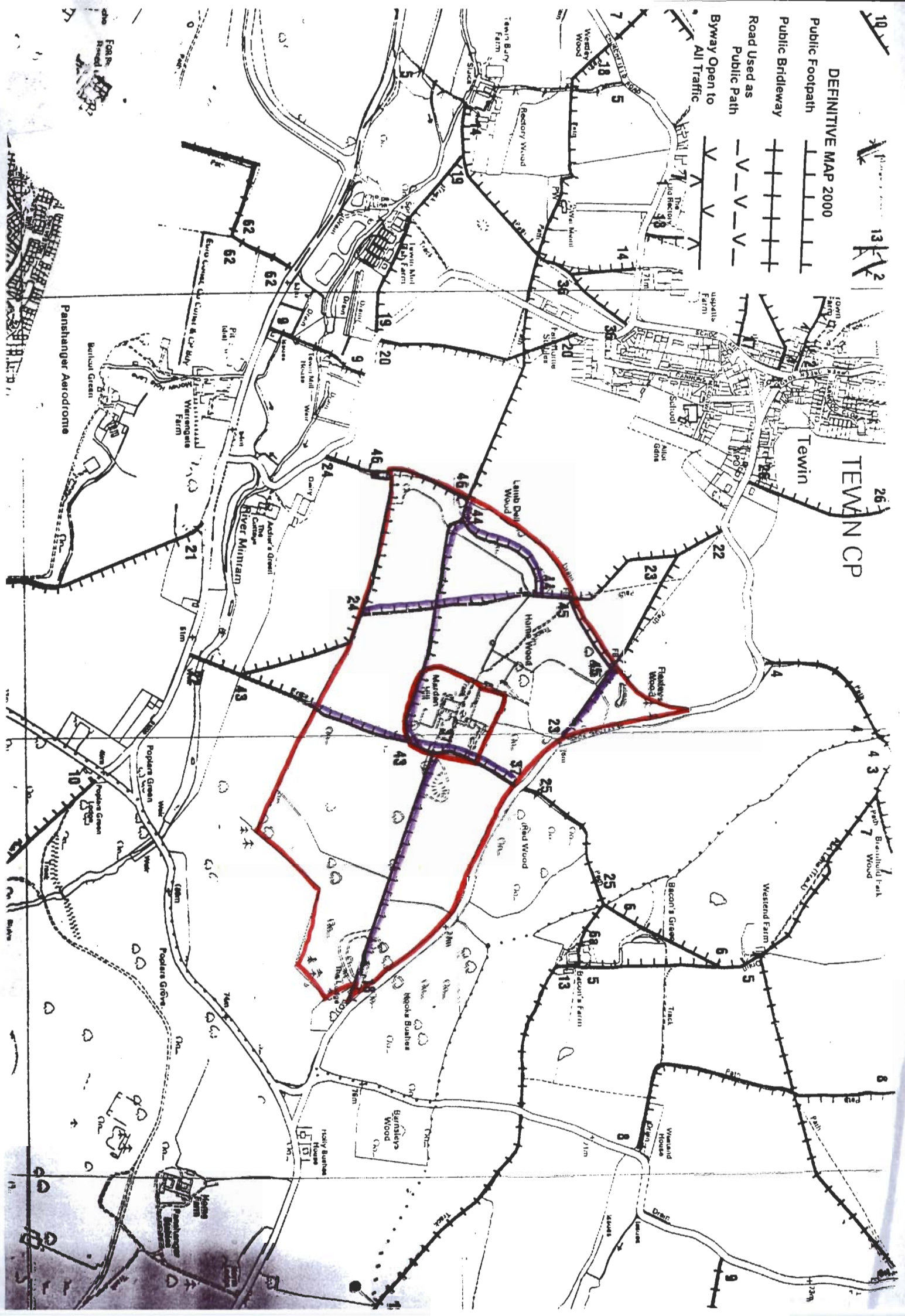

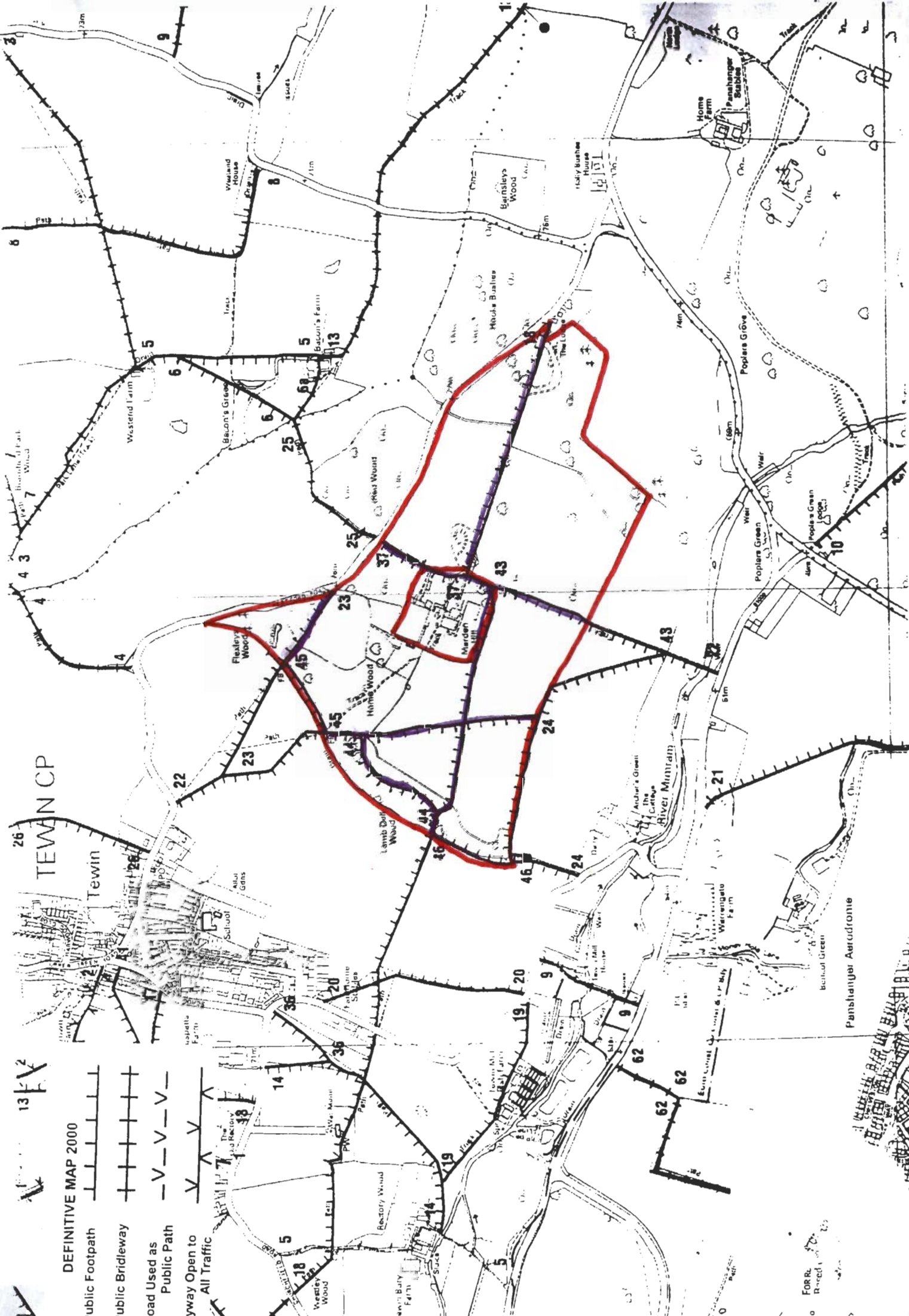
