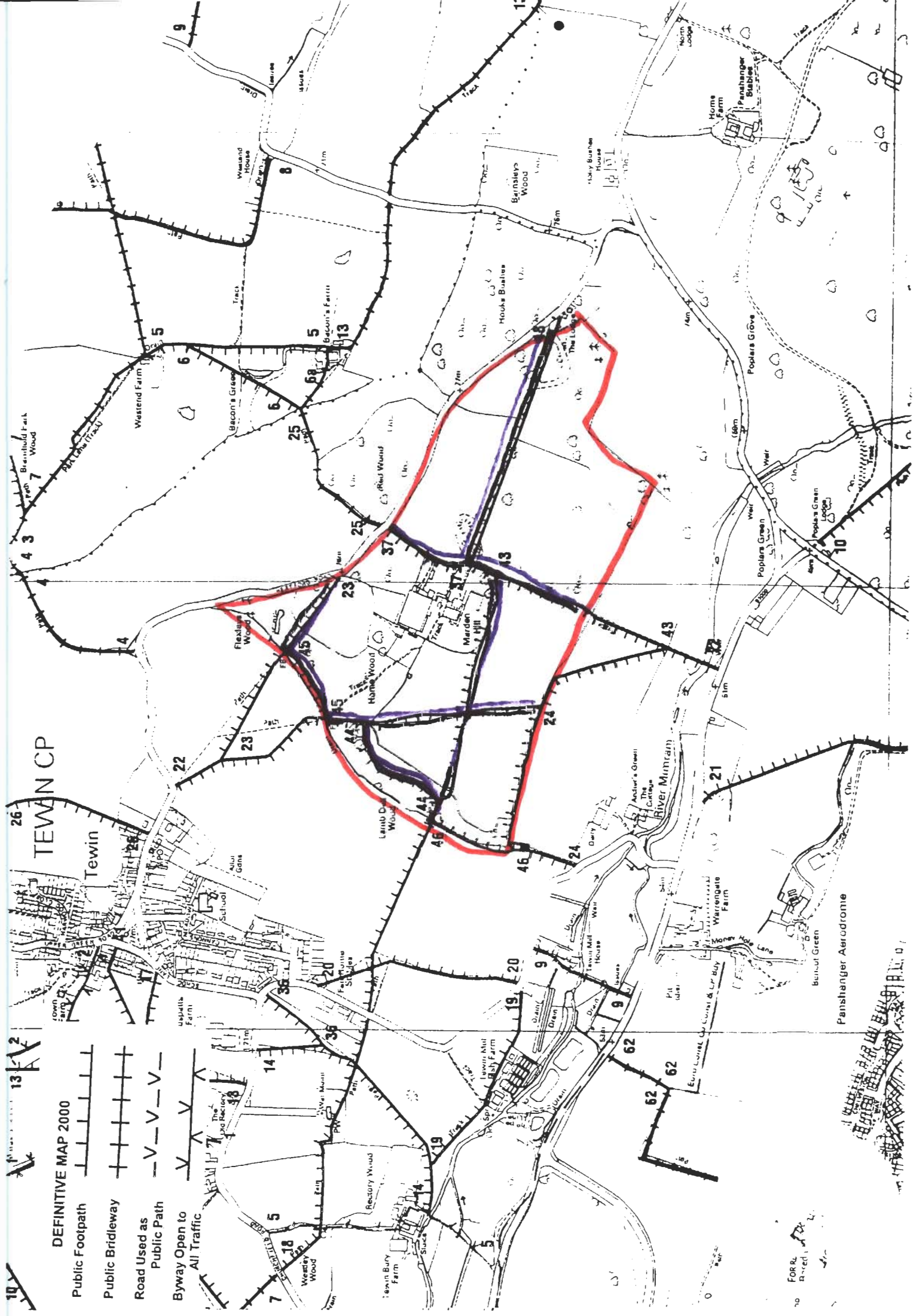

**STATUTORY DECLARATION  
SECTION 31(6) of the HIGHWAYS ACT 1980**

I, \_\_\_\_\_ DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 12<sup>th</sup> October 2000 the owner of the land known as Marden Hill, more particularly delineated on the plan<sup>Marden Hill</sup> accompanying this declaration and thereon edged in red.

2. On the 27th November 2008, I, \_\_\_\_\_, deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that:

\* The ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths.

No additional ways have been dedicated over land edged in red on the plan accompanying this declaration since the statement dated: 27 November 2008 referred to in 2. above (since the date of the statutory declaration referred to in 3. above) other than those \*footpaths, \*bridleways, \*Byways Open to All Traffic, \*Roads Used as Public Paths marked in the appropriate colour on the plan accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
