

Deemed dedication of rights of way

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I, _____ of _____, _____ Near
Welwyn, Hertfordshire AL _____ **DO SOLEMNLY AND SINCERELY DECLARE** as
follows:-

1. I am and have been since 26 March 1997 the owner of the land known as Dawley Wood including Dawley Plantation, Cooks Wood and The Square near Tewin Hertfordshire more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 28th day of April 1997 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 28th day of April 1997 referred to in 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.

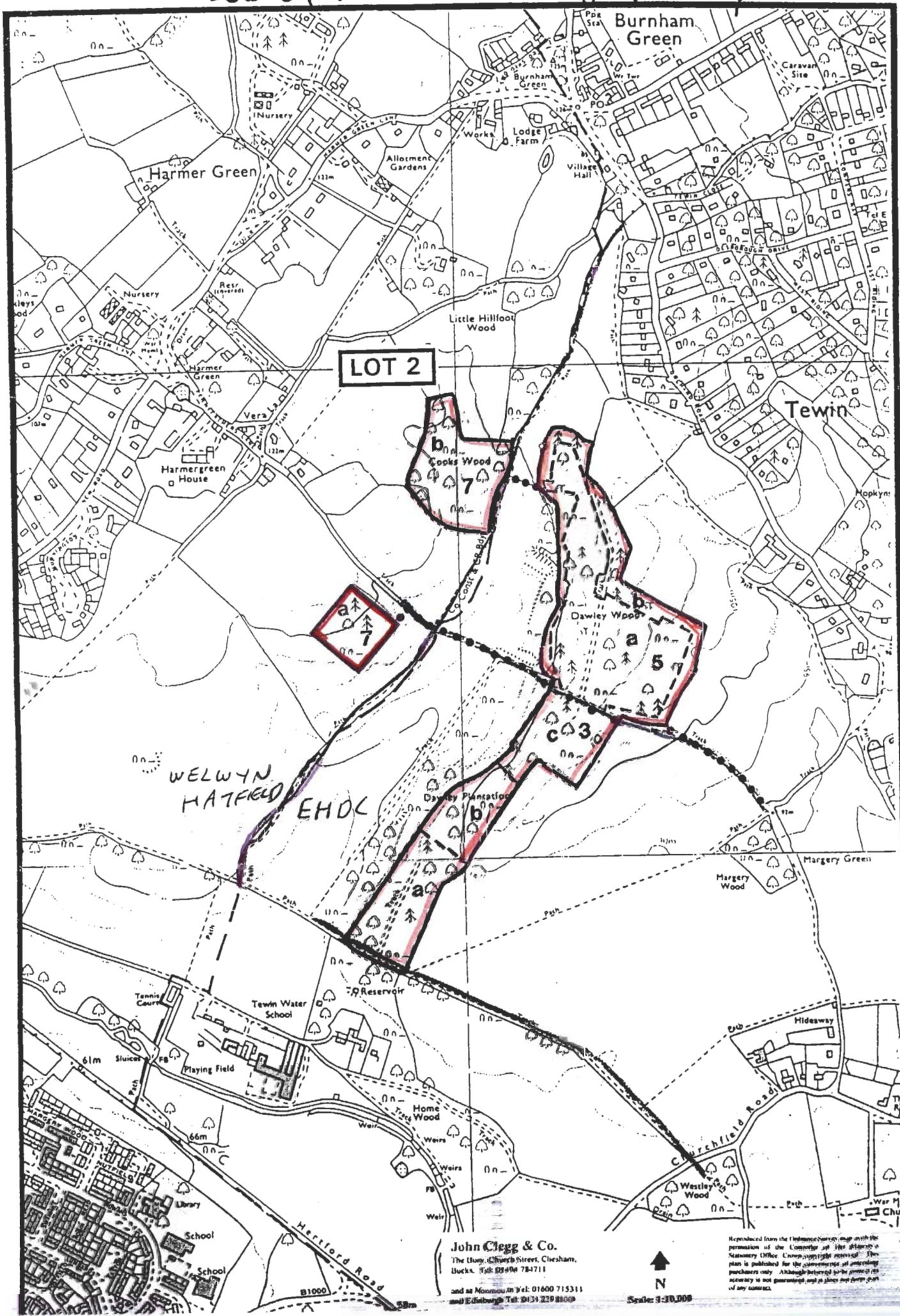
