

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I, DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1 I am and have been since 18th July 1957 the owner of the land known as Partridge Hall Farm, Sandon Nr. Buntingford Hertfordshire and Hill Farm Therfield Nr. Royston Hertfordshire more Particularly delineated on the plans accompanying this declaration and thereon edged red.
- 2 On the 25 April 2002 deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that (the ways coloured purple on the said plans and on the plans accompanying this declaration had been dedicated as footpaths) (no (other) ways had been dedicated as highways over my properties.)
- 3 On the 25 April 2002 deposited with Hertfordshire County Council, being the appropriate Council, a statutory declaration dated stating that no additional ways (other than those marked in the appropriate colour on the plans accompanying this declaration) has been dedicated as (footpaths) since the deposit of the Statement referred to in 2. above.
- 4 No additional ways have been dedicated over the land edged red on the plans Accompanying this declaration since the statement dated referred to in 2. above (since the date of the statutory declaration referred to in 3. above) (other than those footpaths marked in the appropriate colour on the plans accompanying this declaration) and at the present time I have no intention of dedicating any more public rights of way over my property.

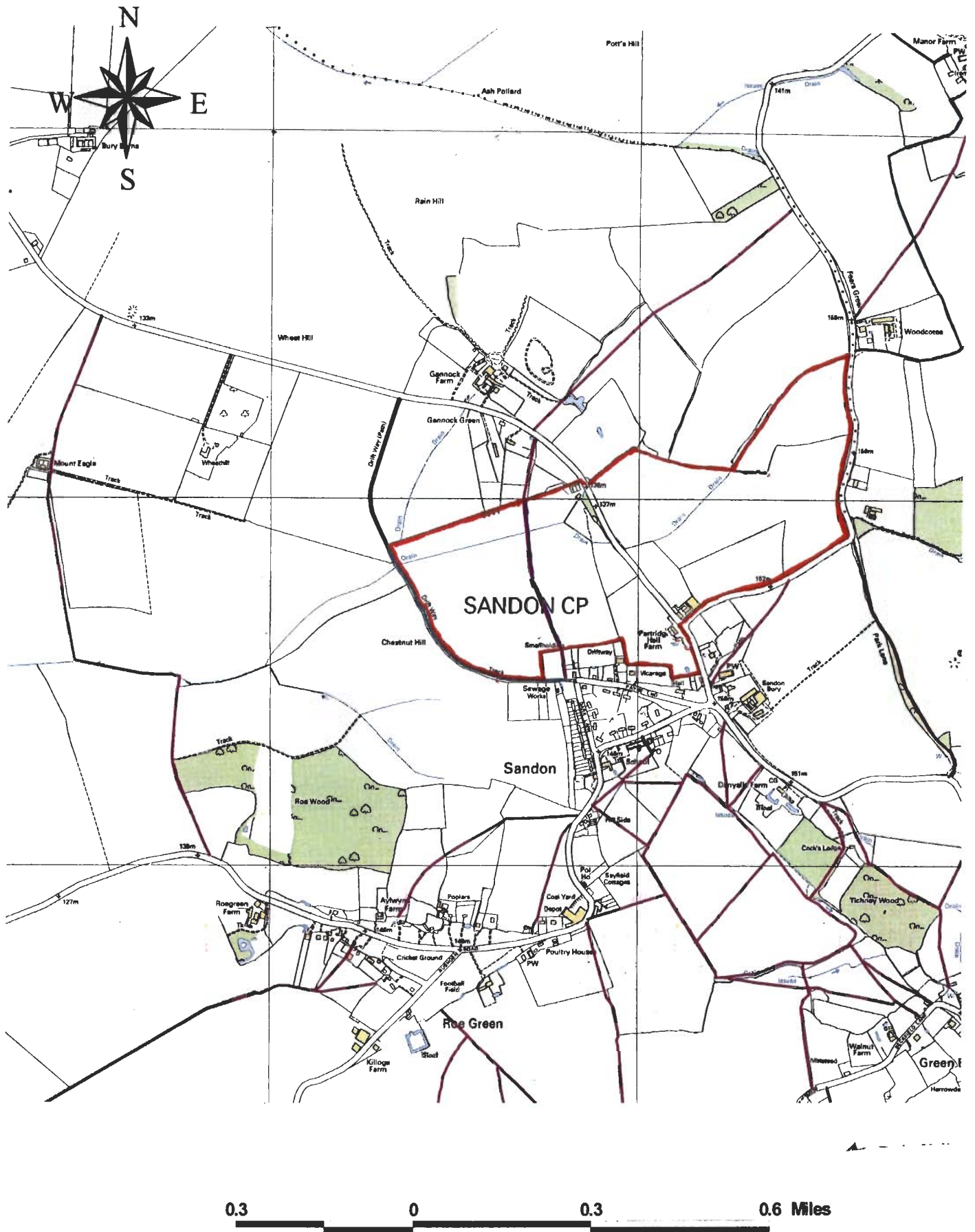
