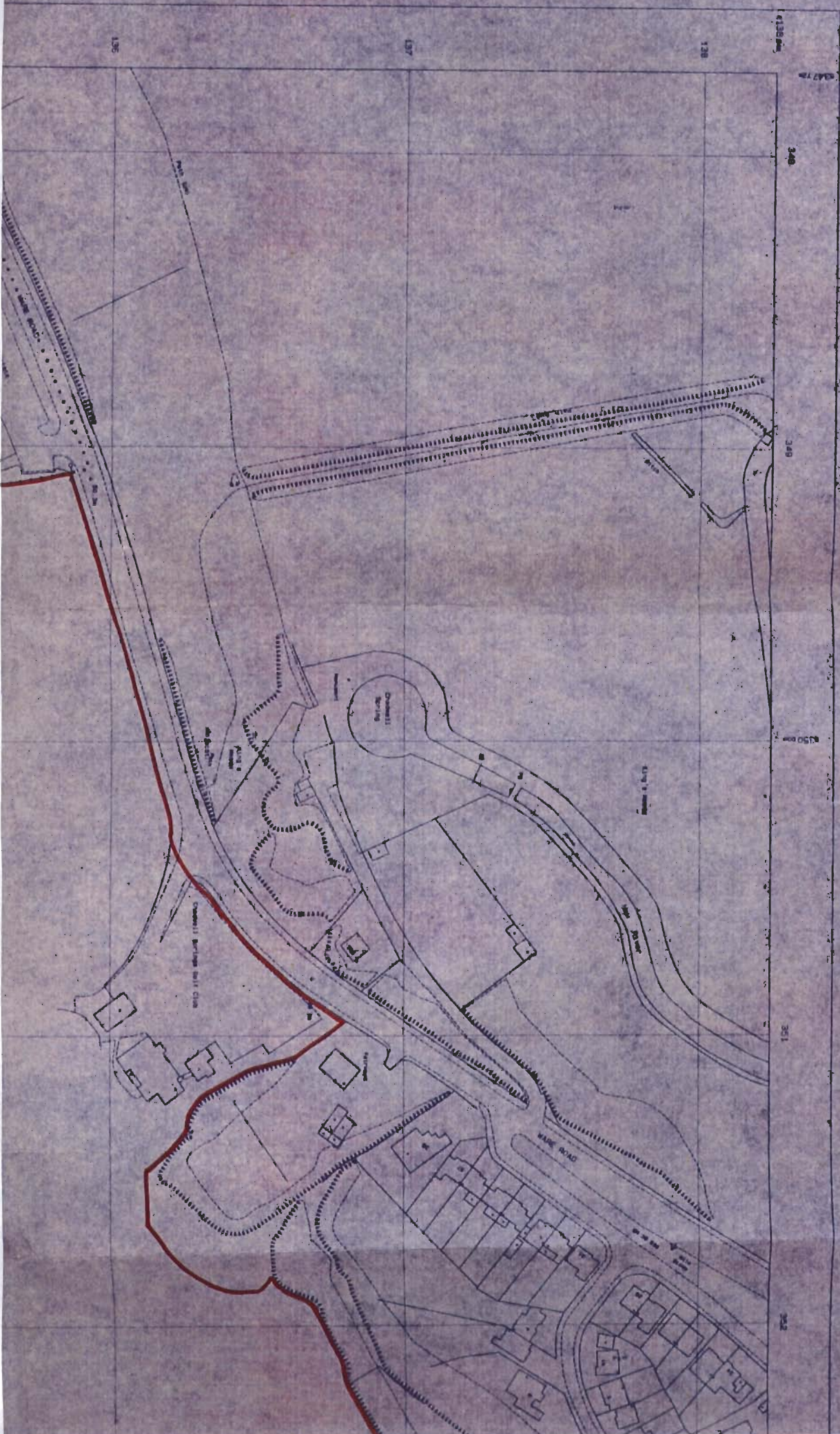

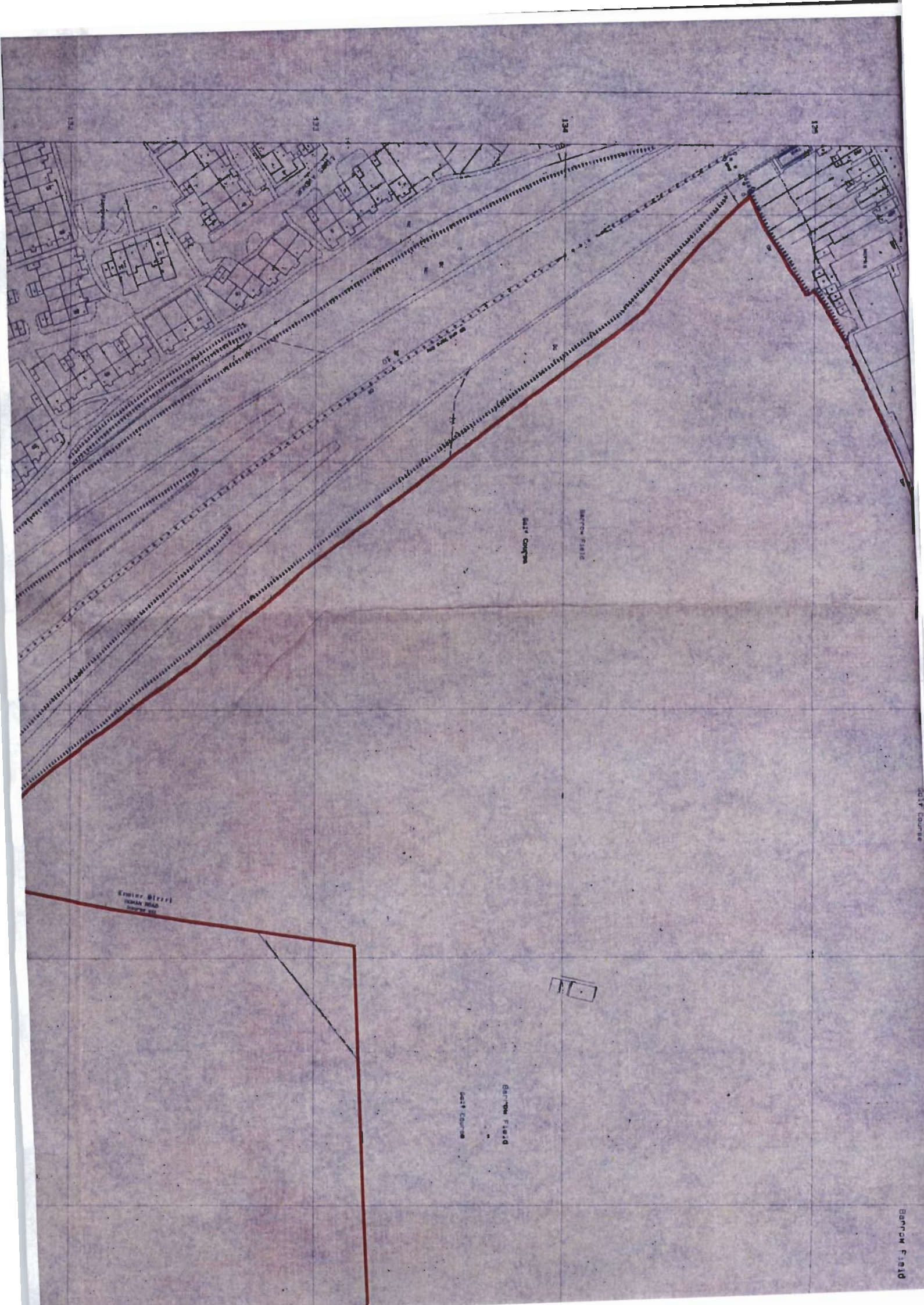

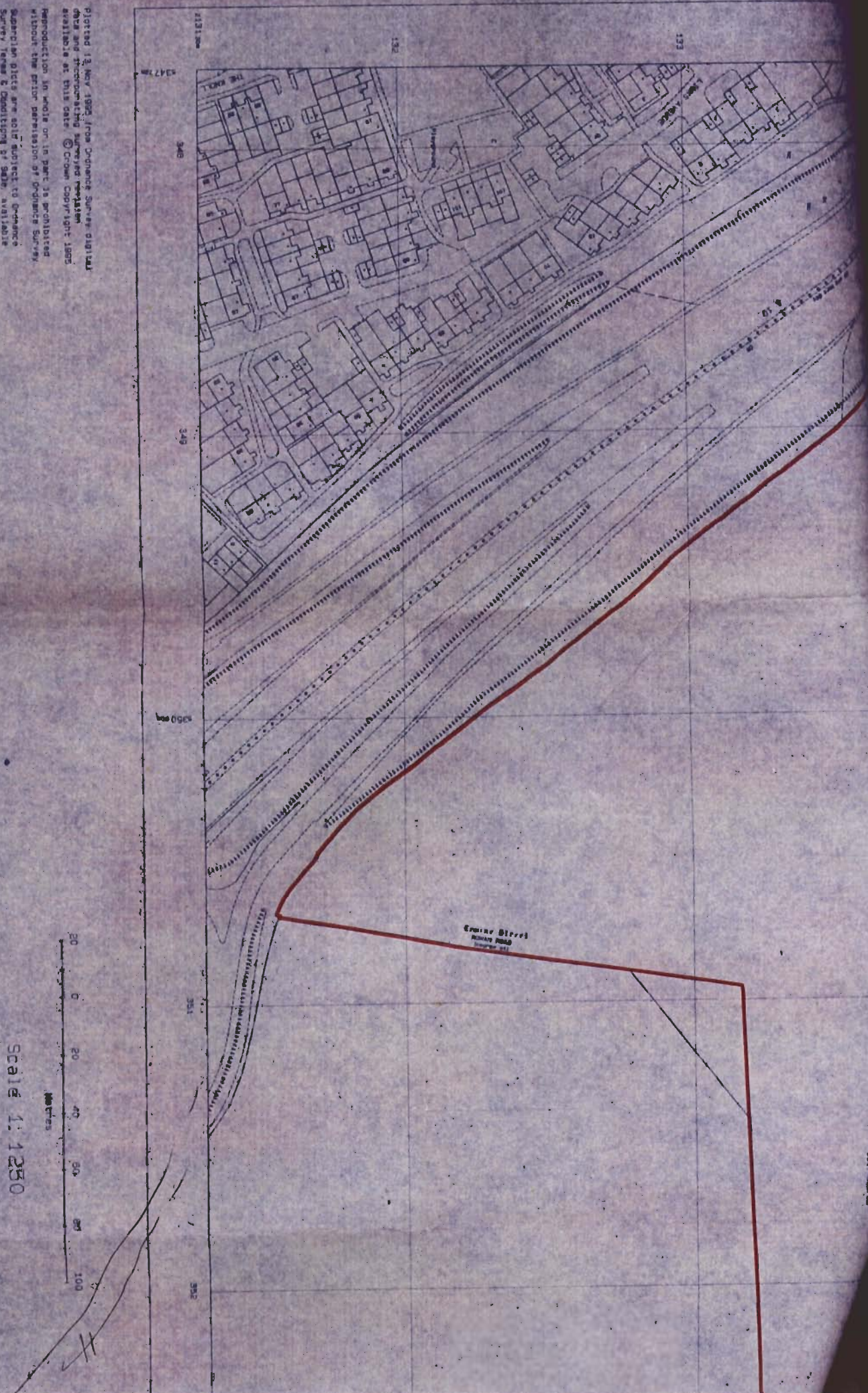

SOLEMNLY AND SINCERELY DECLARE as follows

1 I am a Director of McMullen & Sons, Limited whose registered office is at 26 Old Cross, Hertford, Hertfordshire and am duly authorised to make this statutory declaration on behalf of McMullen & Sons, Limited. McMullen & Sons, Limited is and has been since 5 August 1950 the owner of the land known as Chadwell Springs Golf Club more particularly delineated on the plan accompanying this declaration and thereon edged red.

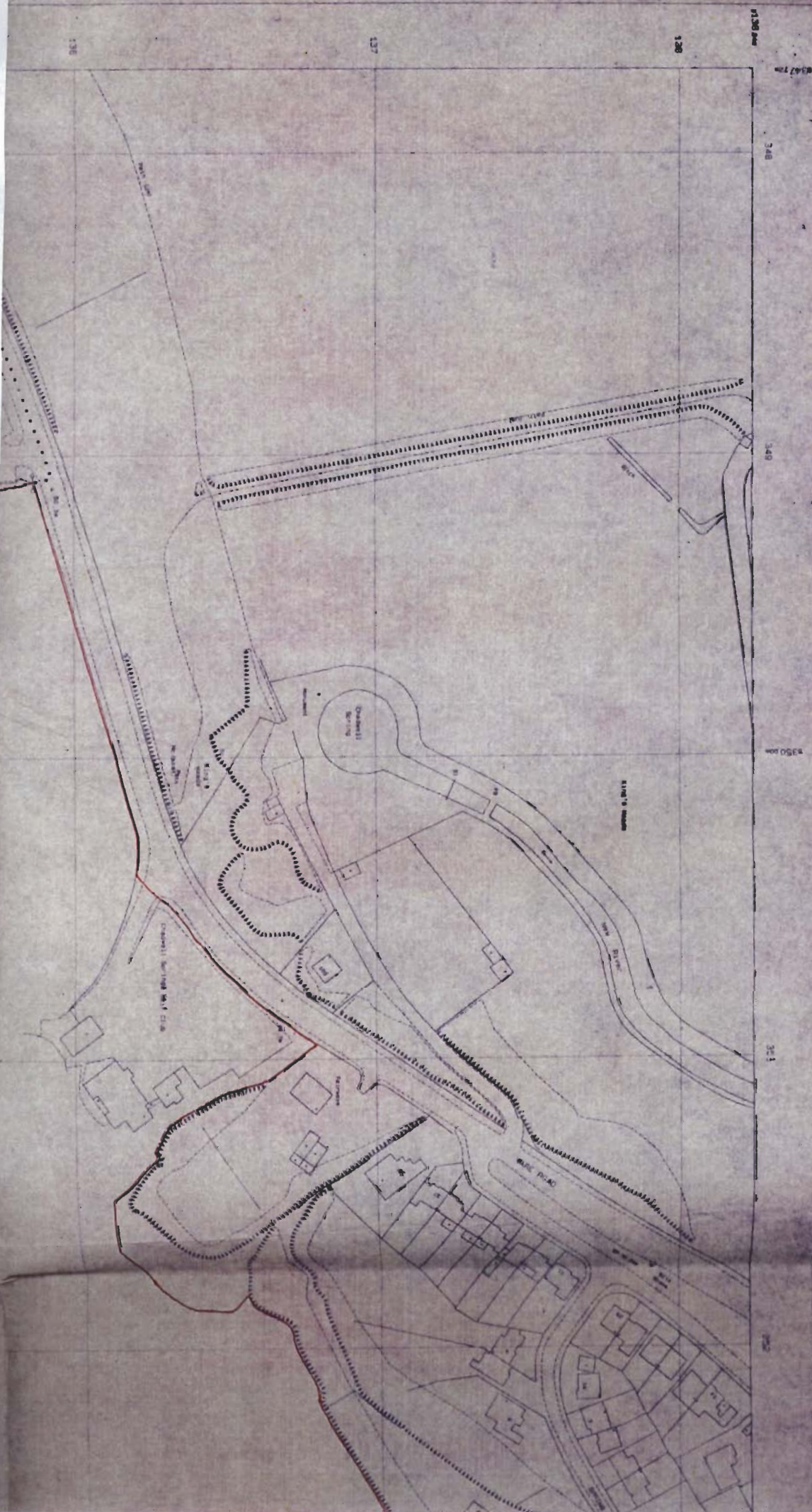


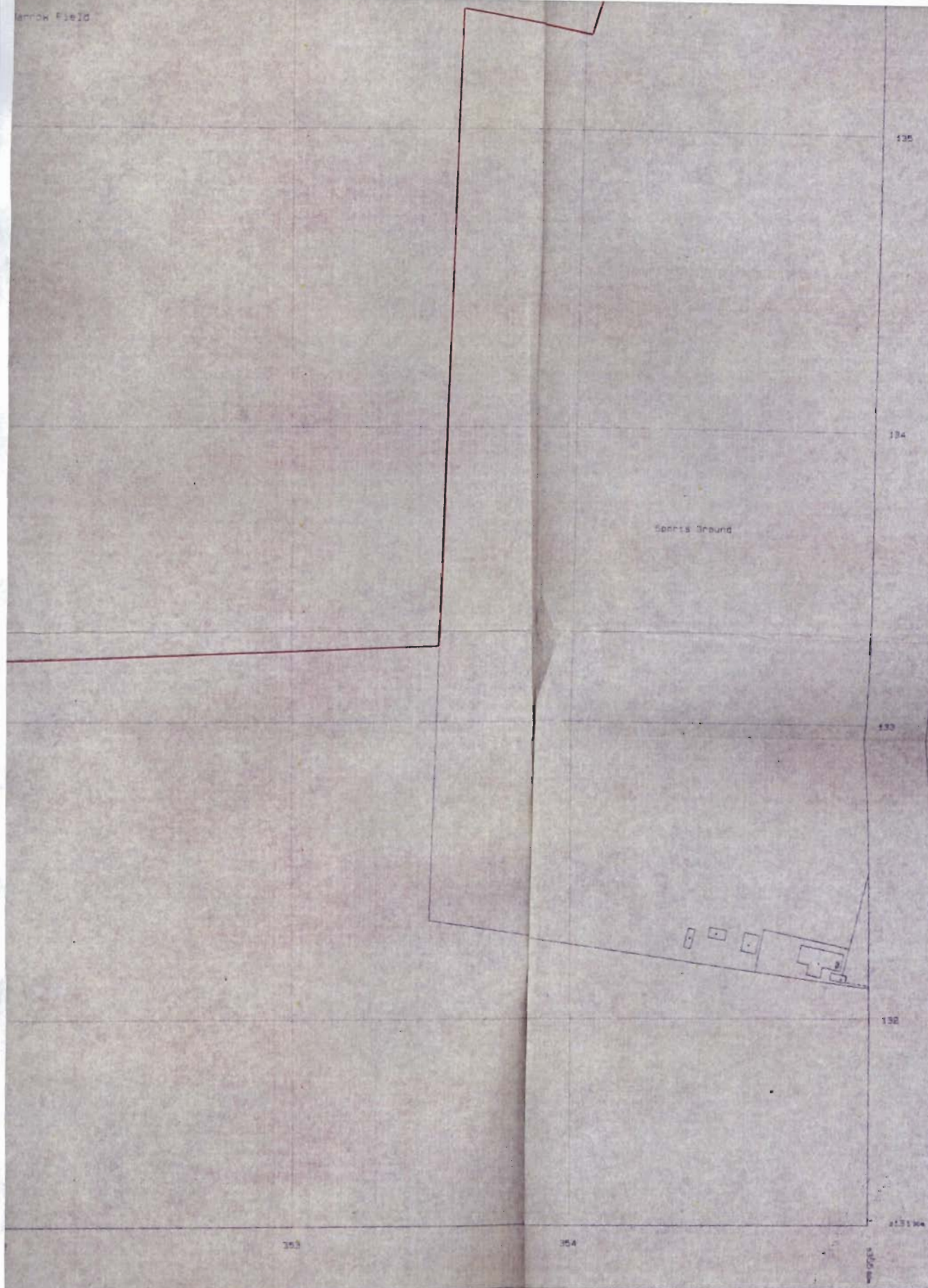
