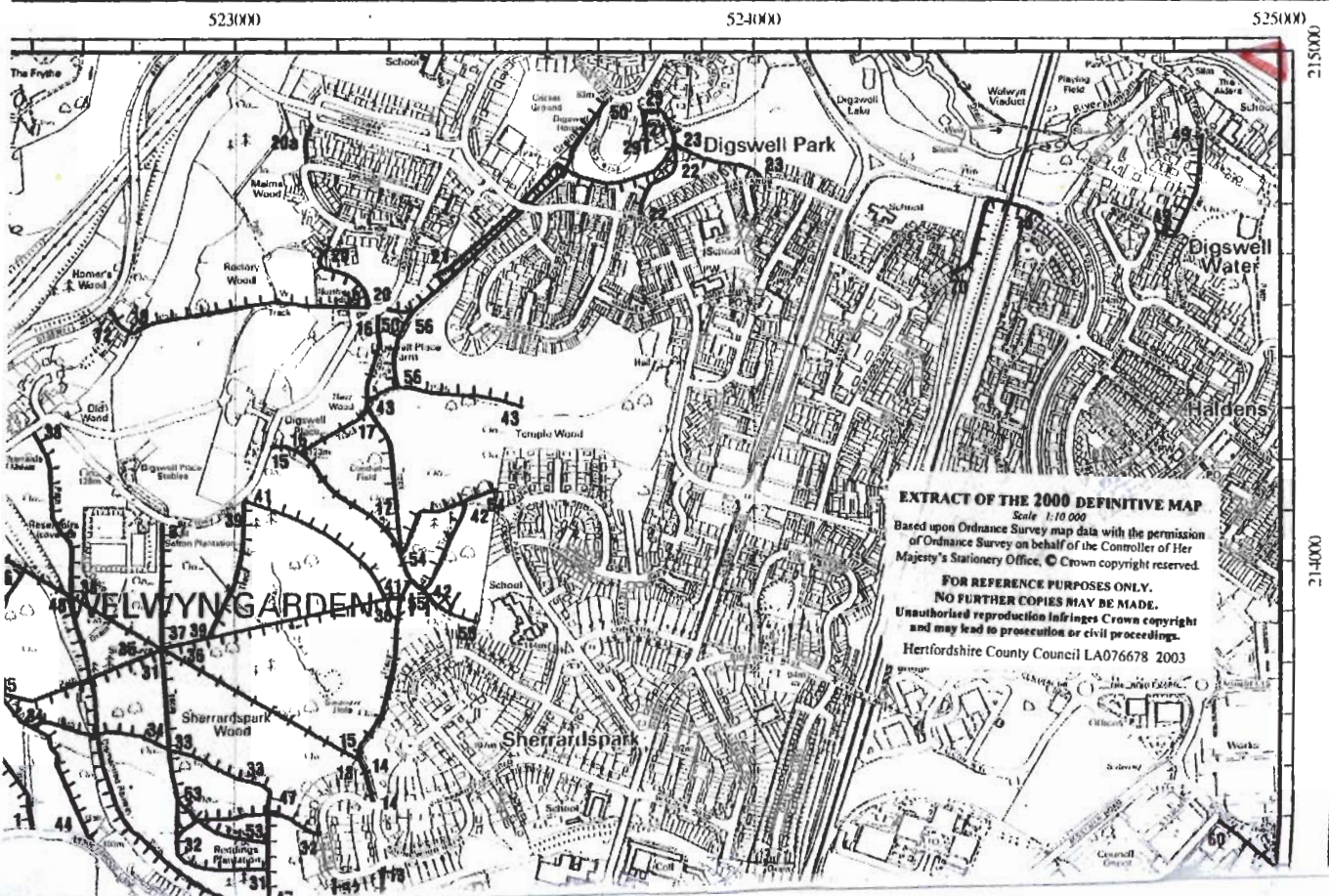

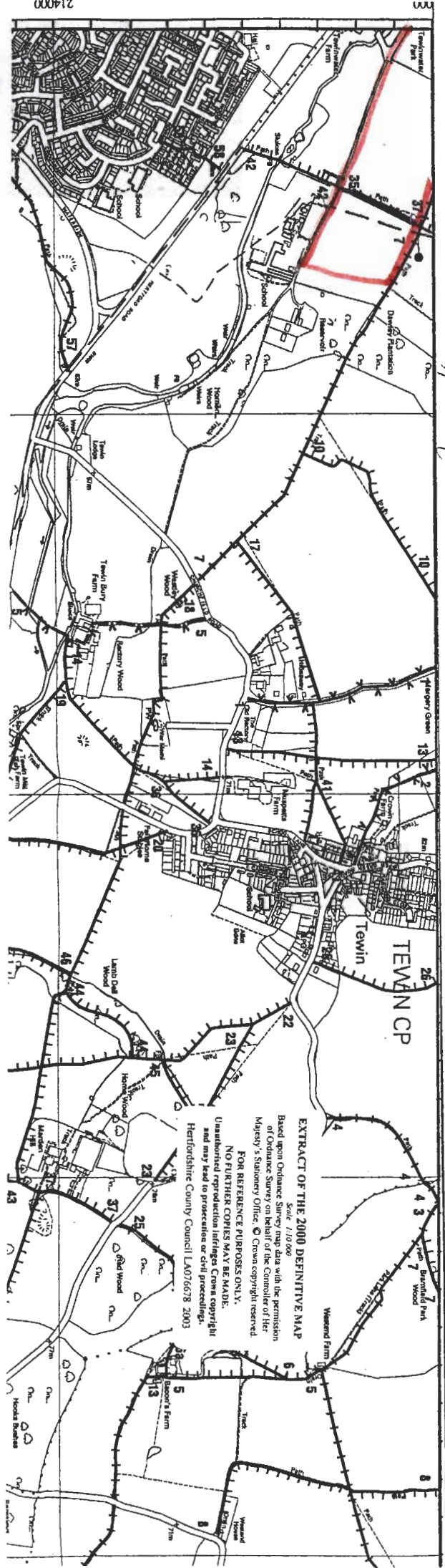
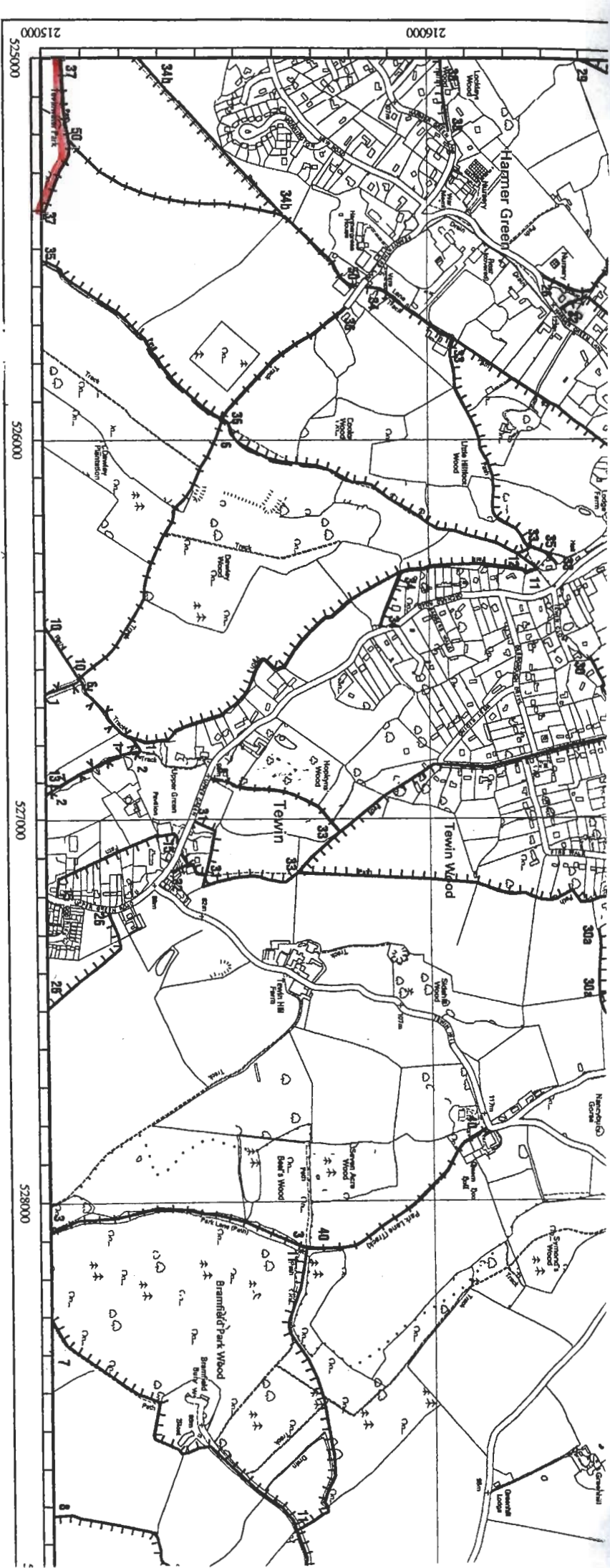

On the 15th day of June 1992 If deposited with Hertfordshire County Council being the appropriate Council, a Statement accompanied by a plan delineating my property by red edging which stated that the way coloured purple and numbered 35 on the said plan and the plan accompanying this Declaration had been dedicated as footpaths and that no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this Declaration since the Statement dated the 15th day of June 1992 referred to in number 2 above and at the present time I have no intention of dedicating any more public rights of way over my property
