SECTION 31(6) HIGHWAYS ACT 1980

Please treat this letter and the attached plan as a plan and notice deposited with the County Council in accordance with Section 31(6) Highways Act 1980 to the effect that only the rights of way shown on the current Definitive Map are acknowledged to be public ways and that no further or additional ways have been dedicated since the issue of Sheet 24.

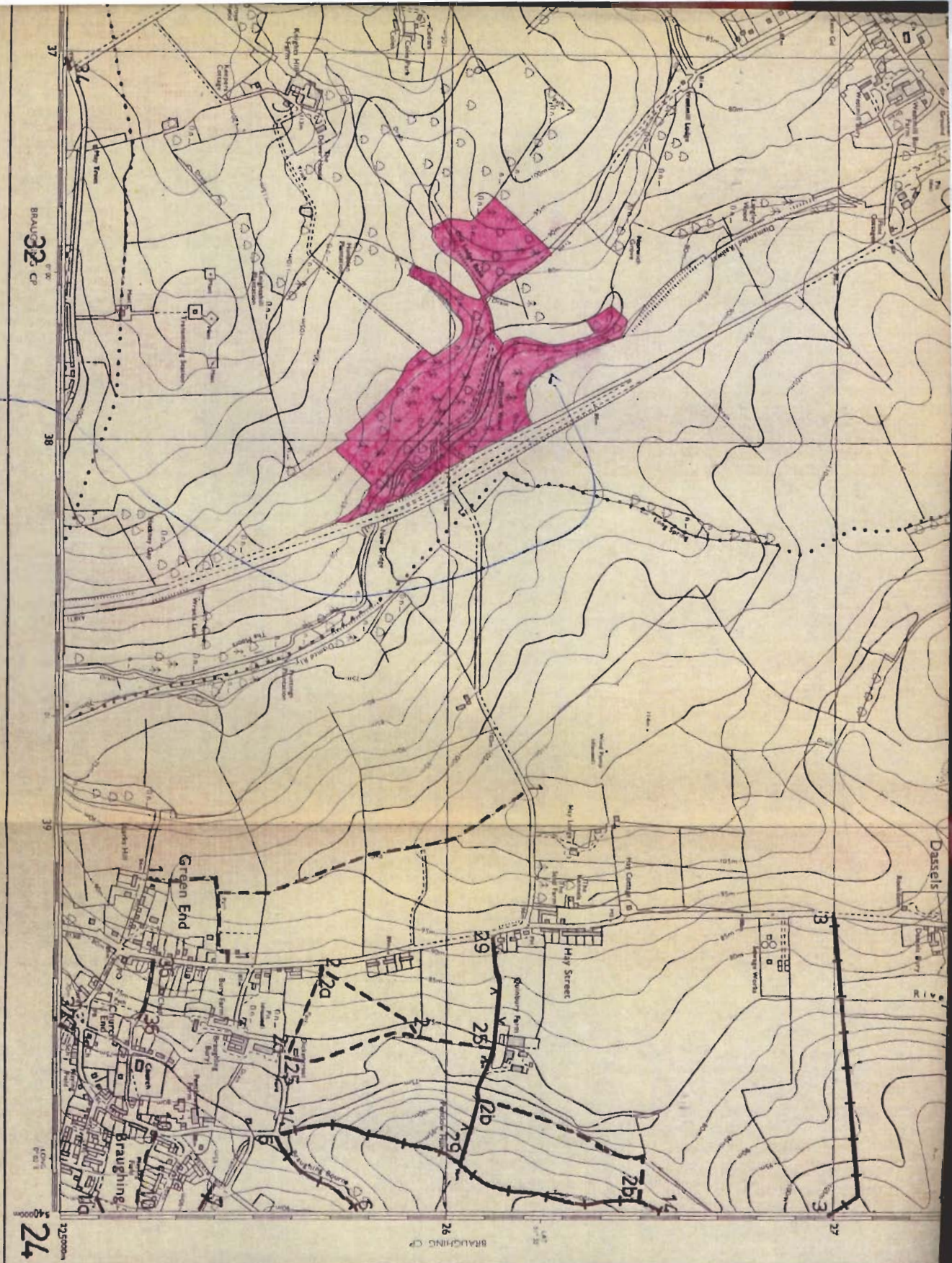
It is my intention within a period of six years from this letter to lodge a Statutory Declaration conforming to Section 31(6)(b)(i) of the above Act.

I am and have been since the Thirty-first day of January One thousand nine hundred and eighty-six the sole owner of the land known as Millcroft Woods Westmill Buntingford Hertfordshire ("the said property") more particularly delineated on the map accompanying this Declaration and thereon coloured pink
