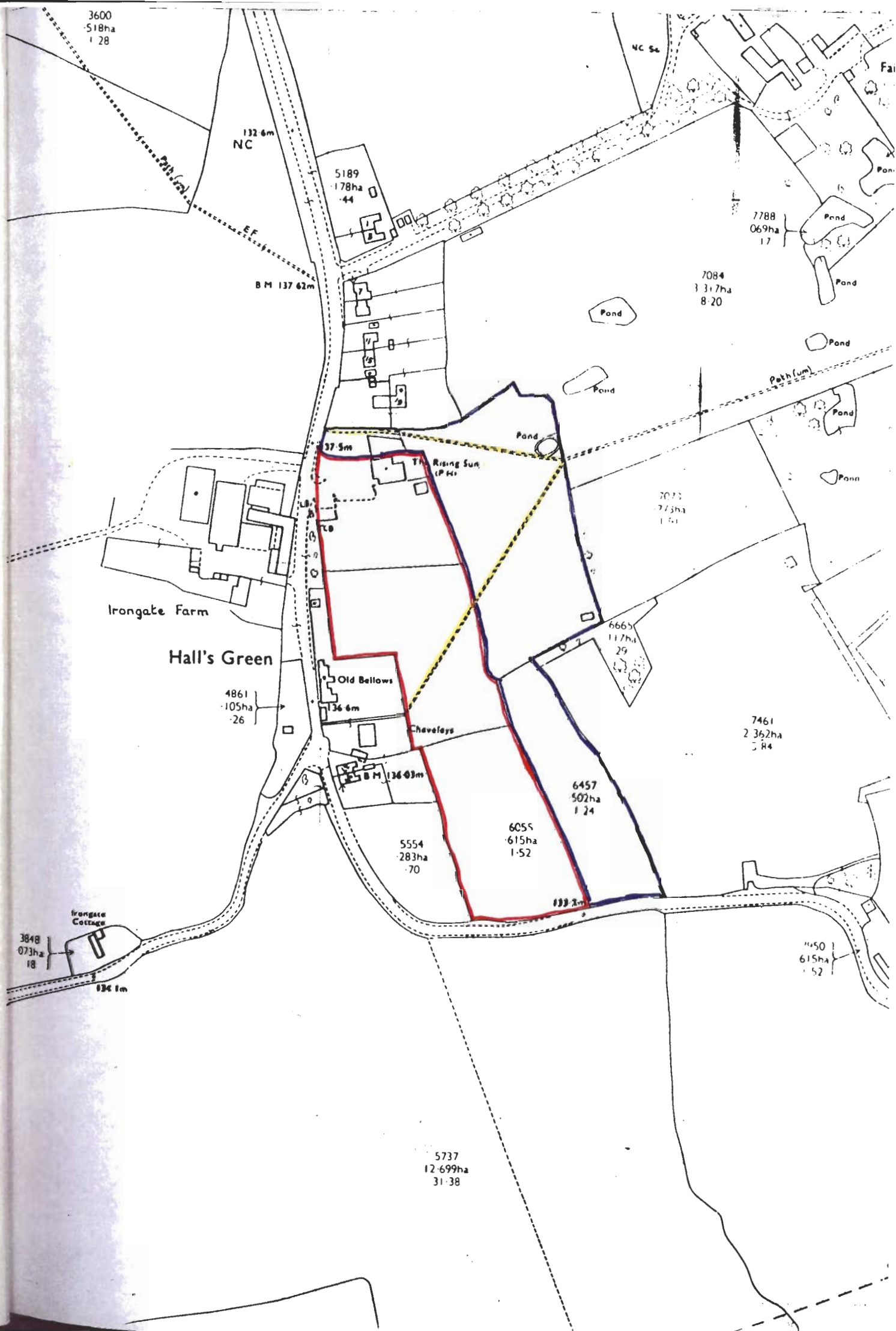

3 No additional ways have been dedicated over the land edged red and blue on the plan marked "KMC3" accompanying this declaration since the statement dated 31 January 1996 referred to in paragraph 2 above.
