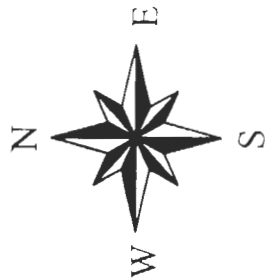

STATUTORY DECLARATION  
SECTION 31 (6) of the HIGHWAYS ACT 1980

WE DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We are and have been since 29 January 1999 the owners of the land known as land adjacent to Woodlands, Sauncey Wood, Harpenden, more particularly delineated on the plan accompanying this declaration and thereon edged in red.
2. On 7 October 2008 we deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and the plan accompanying this declaration had been dedicated as footpaths. No other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over land edged red on the plan accompanying this declaration since the statement dated 7 October 2008 referred to in 2. above and at the present time we have no intention of dedicating any more public rights of way over our property.
