I, \_\_\_\_\_ of Clos du Parcq, La Ruelle du Clos du Parcq, St Brelade, Jersey, JE3 8AQ do solemnly and sincerely declare as follows:-

1. Du Parcq (Jersey) Ltd ("the Owner") is the owner of the land known as land on the north side of Wheathampstead Road Harpenden Hertfordshire ("the Land") registered at the Land Registry under Title Number HD107346 and shown edged red on the map now produced and shown to me and marked "JML1" which is to the best of my knowledge and belief accurate.
2. I am a director of the Owner. I am duly authorised to make this declaration on behalf of the Owner in connection with a deposit of statement and map pursuant to section 31(6) of the Highways Act 1980.
3. On 23 March 1998 KJD, acting on behalf of the Owner's predecessor in title Bedford Holdings Limited ("Bedford"), deposited with Hertfordshire County Council, being the appropriate Council, a statement dated 4 March 1998 accompanied by a map ("the Map") identifying the Land by red edging which stated that the ways coloured purple on the Map (that being the map accompanying this declaration marked "JML1") (and being the ways recorded on the Definitive Map and Statement as footpath numbers 16 and 28) had been dedicated as footpaths over the Land or near to the Land and that no other ways over the Land had been dedicated as highways.
4. On 21 April 1998 KJD, acting on behalf of Owner's predecessor in title Bedford, deposited with Hertfordshire County Council a statutory declaration sworn by me (as a director of Bedford) dated 7 April 1998 confirming the content of the statement dated 4 March 1998 referred to in paragraph 3 above.
5. In September 2003 the Land was transferred to the Owner and KJD, acting on behalf of the Owner, deposited with Hertfordshire County Council a statutory declaration sworn by me (as a director of the Owner) dated 7 April 2004 confirming the content of the statement dated 4 March 1998 referred to in paragraph 3 above.
