
DEPOSIT OF STATEMENT AND PLAN

- 1. I am, and have been since December 1969, the owner of the land known as **Mardleybury Farm**, more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. On the 5th day of November, 2004 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that:

the ways coloured **purple** on the said plan and on the plan accompanying this declaration had been dedicated as **footpaths**;

the ways coloured **green** on the said plan and the plan accompanying this declaration had been dedicated as **bridleways**;

the ways coloured **blue** on the said plan had been dedicated as **highways with at least bridleway rights which may have possible vehicular rights** (Road Used as Public Path, or RUPP).

3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 5th November, 2004 referred to in section 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.




