

STATUTORY DECLARATION

SECTION 31(6) of the HIGHWAYS ACT 1980

I, Edward Nicholas William Brown DO SOLEMNLY AND SINCERLY DECLARE as follows:

- 1 I am and have been since 1<sup>st</sup> September 2006 the owner of the woodland known as Little Barnes Wood and part of Harmergreen Wood more particularly delineated on the plan accompanying this declaration and thereon edged in red.
- 2 On the 9th day of October 2008 I deposited with Hertfordshire County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated no ways had been dedicated as highways over my property.
- 3 No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 9<sup>th</sup> October 2008 referred to in 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.
