FP commencing from the public highway at TL 3115 2711 then N along the track to W of Chirchfield for approx. 35m to TL 3116 2714 then SE along the northern boundary of Chirchfield for approx. 40m to TL 3119 2712 thence NE, NW and NE to junction with FP35 thence SE to Gardners End.

Commences at junction with county road near "Jolly Waggoner" P.H. at Ardeley thence NE past junction with FP34 to the common N of Gardners End and the track at TL 3183 2756. Continuing N across the common and around the E side of the pond for approx. 30m to cross a culvert at TL 3184 2759, then continuing NW around the N side of the pond for approx. 40m to TL 3181 2761, then continuing NE for approx. 210m to join Ardeley BOAT 10 at TL 3195 2776.
