Commences at junction with BR5 (Sacombe Park) at parish boundary between Home Wood and Low Wood thence SE through Cold Harbour Wood and Furzeground Wood to parish boundary and junction with BR35 in Thundridge parish.

Commences at junction with FP 6 and A602 Ware Road W of Tonwell at TL 3318 1722 thence SE along boundary of Ware Road to TL 3323 1714 thence SW to junction with county road at Chapmore End.

Commences at junction with county road SW of Well House, Chapmore End thence SE and E along parish boundary to bottom of embankment at W side of county road A602 at TL 3374 1634 thence generally N up side of embankment for approx 40m to edge of road at TL 3375 1637.

Commences as Bridleway from the junction with Hertford RB 8 and Bengeo Rural FP 13 at TL 3196 1546 and runs NE towards the SE corner of Bardon Clumps at TL 3200 1555 then continuing outside the E edge of the wood and parallel to Bengeo Rural 22 for a total distance of approx. 385m to TL 3214 1579. Continues as Footpath to the junction with FP14 NW of Rickneys.

Commences at parish boundary in continuation of FP4 (Hertford Borough) thence NW along parish boundary to junction with BR12.

Commences at E edge of county road A602 at TL 3376 1638 thence generally SE down side of embankment for approx 40m to TL 3378 1635 thence generally E to join the bypassed section of the county road S of Paynes Hall.

Commences from Bengeo Rural FP10 at the bottom of the western embankment of the A602 (TL 3375 1636) and runs generally N for approx. 50m to TL 3373 1641 then generally E through the tunnel under the A602 for approx. 30m to TL 3376 1642 then generally S for approx. 50m to join Bengeo Rural FP25 at the bottom of the eastern embankment of the A602 (TL 3377 1637).

**Width** 2m between TL 3375 1636 and TL 3373 1641 and between TL 3376 1642 and TL 3377 1637. The width of the tunnel between TL 3373 1641 and TL 3376 1642.
